SUBSIDIARY LEGISLATION.

A PROCLAMATION.

H. R. PALMER,
Governor.

In exercise of the powers vested in me by the Importation of Textiles (Quotas) Law, 1934, I, Herbert Richmond Palmer, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Commander of the Most Excellent Order of the British Empire, Governor and Commander-in-Chief in and over the Colony of Cyprus, do hereby proclaim as follows :—

1. In this Proclamation—

“ foreign country ” means any country or territory specified in the first column of the Schedule hereto ;

“ textile goods ” means piece goods containing fifty per cent. or more of cotton, silk or artificial silk, or of cotton, silk or artificial silk combined ;

“ quota ” means the total quantity of textile goods manufactured in a foreign country, or in any country or territory to which paragraph 3 of this Proclamation applies, which may be imported into the Colony of Cyprus ;

“ quota period ” means the period commencing on the 1st day of January and ending on the 31st day of December, 1938, both days inclusive.

2. The quota appearing in the second column of the Schedule hereto against the name of each foreign country shall be the quota in respect of textile goods for such foreign country during the quota period.

3. The quota for any country or territory, not being a part of the British Empire and not specifically enumerated in the Schedule hereto, shall be 112,500 yards in the case of each such country or territory during the quota period.

THE LAND ACQUISITION LAWS, 1899 TO 1936.

NOTIFICATION UNDER SECTIONS 2, 3 AND 4.

Whereas it has been represented to me that it is desirable in the public interest to establish a Government plantation at the village of Strovolos in the District of Nicosia :

Now, therefore, I, Herbert Richmond Palmer, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Commander of the Most Excellent Order of the British Empire, Governor and Commander-in-Chief in and over the Colony of Cyprus, by virtue of the powers vested in me by sections 2, 3 and 4 of the Land Acquisition Laws, 1899 to 1936, do hereby declare the acquisition of land at the village of Strovolos in the District of Nicosia and the establishment thereon of a Government plantation to be an undertaking of public utility, and do hereby authorize the carrying out of the said undertaking and do hereby entrust to the Conservator of Forests the supervision and effectuation of the said undertaking.
