**No. 180. Notification under the Tree Planting Village Areas Laws, 1930 to 1936.**

**AYIA VARVARA (NICOSIA) FUND.**

In exercise of the powers vested in me by the Tree Planting Village Areas Laws, 1930 to 1936, I hereby establish a fund for the village of Ayia Varvara, in the District of Nicosia, (hereinafter called the "Fund"), into which shall be paid all fines recovered under the said Laws for offences committed within the Tree Planting Area of the village of Ayia Varvara, as described in the Order of the Governor made the 17th day of August, 1937, and published in Supplement No. 3 to the *Gazette* No. 2602 of the 20th August, 1937.

The Fund shall be under the management and control of the Commissioner of Nicosia for the time being.

The money in the Fund shall be utilized for works of public utility in the village of Ayia Varvara.
