And whereas the Mukhtar of the village of Xyliatos has forwarded to the Commissioner of the District of Nicosia a report, signed and sealed by him, containing a description with boundaries of the said area and stating that the said area fulfils the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed:

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Colonial Secretary for the consideration of the Acting Governor:

And whereas the Acting Governor considers it expedient, having regard to all the circumstances, that the area in the said report described should be reserved as the Tree Planting Area of the village of Xyliatos.

Now, therefore, His Excellency the Acting Governor, in exercise of the powers vested in the Governor by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows:—

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Xyliatos in the District of Nicosia.

The boundary commences at the most northern point of plot No. 702 of the Government Survey plan No. XXIX/49, locality "Alestos," on a footpath and on the boundary of the village of Xyliatos, and proceeds south-eastwards along this footpath through plots Nos. 44 and 45 of the Government Survey plan No. XXIX/50, plot No. 705 of the Government Survey plan No. XXIX/49, plots Nos. 46, 48 and 51, of the Government Survey plan No. XXIX/50, along the northern boundary of plot No. 60 of the said plan and plots Nos. 9, 12, 11, 14 and 155 of
