

Now, therefore, His Excellency the Acting Governor, in exercise of the powers vested in the Governor by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows :—

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Trakhypedhoula in the District of Paphos.

SCHEDULE.

The boundary commences at the most northern point of plot No. 520 of the Government Survey plan No. XLVI/52, which point is on the boundary of the village of Trakhypedhoula, and proceeds south-eastwards along the said village boundary to the most western point of plot No. 198 of the Government Survey plan No. XLVI/53 ; thence south-eastwards along the boundaries of, and including in the reserved area, plots Nos. 200, 199, 191, 190, 183, 179, 178, 177, 176, 175 and 214 of the said plan to the most southern point of plot No. 183 of the said plan, on the left bank of the stream " Argaki Ledhia " ; thence westwards along the left bank of the said stream to the most eastern point of plot No. 203 of the said plan ; thence westwards and southwards along the boundaries of, and including in the reserved area, plot No. 203 of the said plan, plots Nos. 779, 781, 744, 743, 742, 741, 740 and 720 of the Government Survey plan No. XLVI/52 to the most southern point of plot No. 719 of the said plan, on a footpath ; thence north-westwards along this footpath to the most northern point of plot No. 664 of the said plan ; thence south-westwards along the boundaries of, and including in the reserved area, plots Nos. 664, 663, 648 and 646 of the said plan, plots Nos. 69 and 68 of the Government Survey plan No. XLVI/60, plot No. 618 of the Government Survey plan No. XLVI/52, plots Nos. 44, 43, 41, 48 and 35 of the Government Survey plan No. XLVI/60, to the most western point of plot No. 35 of the said plan, on the left bank of the stream " Argaki Klimonas " and on the boundary of the village of Trakhypedhoula ; thence northwards along the said village boundary to the point of commencement.

The area reserved comprises 1,330 donums approximately, as shown edged in red on plan filed in D.L.R.S. M.P. 503/37.

THE COURTS OF JUSTICE LAW, 1935.
