**No. 170. The Irrigation Divisions (Villages) Law, 1938.**

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Law, 1938, the following Rules made by the Committee of the Irrigation Division of Angastina, Mousoulita, Marathovouno, Yenagra, Pyrga and Prastio (Pedias) in the District of Famagusta, are published in the *Gazette*. (M.P. 1227/23.)

IRRIGATION DIVISION OF ANGASTINA, MOUSOULITA, MARATHOVOUNO,  
YENAGRA, PYRGA AND PRASTIO, (PEDIAS).

*Rules.*

1. These Rules may be cited as the Irrigation Division of Angastina, Mousoulita, Marathovouno, Yenagra, Pyrga and Prastio (Pedias) Amendment Rules, 1938, and shall be read as one with the Irrigation Division of Angastina, Mousoulita, Marathovouno, Yenagra, Pyrga and Prastio (Pedias) Rules, 1932, (hereinafter called the "Principal Rules"), and the Principal Rules and these Rules may together be cited as the Irrigation Division of Angastina, Mousoulita, Marathovouno, Yenagra, Pyrga and Prastio (Pedias) Rules, 1932 and 1938, *Gazette: 23.12.1932.*

2. The Principal Rules are hereby amended by the insertion of the following Rule after Rule 10 :—

" 10A. The Committee of the Irrigation Division may determine from which channel each field capable of being benefited by the works shall be irrigated and no person shall irrigate his field from any other channel than that approved by the Irrigation Committee."

**No. 171. The Irrigation Divisions (Villages) Law, 1938.**

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Law, 1938, the following Rules made by the Committee of the Irrigation Division of Dhali, in the District of Nicosia, are published in the *Gazette*. (M.P. 943/35.)

IRRIGATION DIVISION OF DHALI.

*Rules.*

1. These Rules may be cited as the Irrigation Division of Dhali (Amendment) Rules, 1938, and shall be read as one with the Irrigation Division of Dhali Rules, 1935, (hereinafter called "the Principal Rules"), and the Principal Rules and these Rules may together be cited as the Irrigation Division of Dhali Rules, 1935 and 1938. *Gazette: 1.11.1935*

2. Rule 5 of the Principal Rules is hereby amended by the insertion immediately after the word "annum" of the words "as may be prescribed by the Committee from time to time".
