eastern point of plot No. 343/74 of the said plan, where it is joined by another road ; thence westwards along the latter road and northwards along its continuation to the north-eastern corner of plot No. 344 of the said plan on the main road from Nicosia to the village of Yerolakkos: thence westwards along the northern side of the latter road to the south-western corner of plot No. 326 of the said plan where the road to Ayios Pavlos Church leaves the main road; thence north-eastwards. along the eastern side of the road to Ayios Pavlos Church to the southwestern corner of plot No. 265 of the Government Survey plan No. XXI/45. locality "Avios Pavlos," on a track; thence northwards along this track to the north-eastern corner of plot No. 249 of the said plan and westwards along the northern boundary of the last mentioned plot to its north-western corner on another track; thence south-westwards along the eastern side of this track to the cross-roads at the most southern point of plot No. 166 of the said plan; thence northwards along the eastern side of the road to Bimbashi Chiftlik to the southern boundary of the Cyprus Government Railway; thence north-eastwards along this boundary of the railway to the road from the tannery near the Golf Course to the village of Trakhonas ; thence northwards along the eastern side of the last mentioned road to the point of commencement, all which said boundary is shown edged red on the Government Survey plan Serial No. 1151.
