THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

## ORDER MADE UNDER SECTION 13.

H. R. PALMER, Governor.

Whereas at a meeting duly convened and held at the village of Akanthou, in the District of Famagusta, on the 15th May, 1938, it was determined by the requisite majority of the voters present thereat that a certain area should be reserved as the Tree Planting Area of the village of Akanthou:

And whereas at the said meeting the boundaries of the said area have been fixed and described:

And whereas the Mukhtar of the village of Akanthou has forwarded to the Commissioner of the District of Famagusta a report, signed and sealed by him, containing a description with boundaries of the said area and stating that the said area fulfils the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed:

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Colonial Secretary for the consideration of the Governor:

And whereas the Governor considers it expedient, having regard to all the circumstances, that the area in the said report described should be reserved as the Tree Planting Area of the village of Akanthou.

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows:—

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Akanthou in the District of Famagusta.

## SCHEDULE.

The boundary commences at the most northern point of plot No. 477 of the Government Survey Plan No. XIV/5, and proceeds southeastwards along the north-eastern boundary of the said plot to the ridge which runs through plot No. 486 of the said plan; thence eastwards along this ridge to the north-western corner of plot No. 472 of the said plan; thence along the boundaries of, and including, plots Nos. 472 and 470 of the said plan to the most northern point of plot No. 470 of the said plan on a road; thence north-eastwards in a straight line to the ridge running through plot No. 208 of the said plan; thence north-eastwards along the said ridge to the point due north of the most northern point of plot No. 372 of the said plan; thence due southwards in a straight line to the most northern point of plot No. 372 of the said plan, locality "Plakes"; thence south-eastwards along the boundaries of, and including, plots Nos. 372 and 373 of the said plan, plot No. 154 of the Government Survey Plan No. XIV/6, plots Nos. 441, 521, 632, 635, 751, 752 and 753 of the Government Survey Plan No. XIV/5 to the south-eastern corner of plot No. 843 of the said plan, which point is on the forest delimitation line of "Kantara" Forest; thence south-westwards along the forest delimitation line through Forest Cairns Nos. 12, 11, 10, 9 to Forest Cairn

No. 8; thence south-westwards along the boundaries of, and including, plots Nos. 800, 801, 802, 803, 806, 805, 804, 807 and 679 of the Government Survey Plan No. XIV/5 to the north-western corner of plot No. 670 of the said plan; thence north-eastwards along the ridge running through plots Nos. 671 and 577 of the said plan to the most western point of plot No. 578 of the said plan, locality "Plakes"; thence north-eastwards along the boundaries of, and including, plots Nos. 578, 579, 584 and 477 to the point of commencement.

The area reserved comprises 1,265 donums approximately, and is shown edged red on the plan filed in D.L.R.S. M.P. 379/38.

THE DISEASES OF PLANTS PREVENTION LAW, 1893.

ORDER MADE UNDER SECTION 3 (1).

In exercise of the powers vested in him by section 3 (1) of the Diseases of Plants Prevention Law, 1893, His Excellency the Governor is pleased to order and it is hereby ordered as follows:—

- 1. This Order may be cited as the Mussel Scale Order, 1938.
- 2. In this Order, unless the context otherwise requires,—
- "Agricultural Officer" means all officers of the Agricultural Department and any other person or persons as shall be appointed in writing by the Director of Agriculture for the purposes of this Order;
- "Quarantine Inspector" means any person or persons appointed in writing by the Director of Agriculture to carry out the duties of a Quarantine Inspector: Provided that each Quarantine Inspector when on duty shall wear on each upper arm a band of cloth or other material of a red colour not less than 3 inches wide bearing the letters A. D. in yellow and not less than 2 inches in height;
- "citrus tree" means any tree, plant or seedling of citron, grapefruit, lemon, lime, mandarine or orange or any part of any such tree, plant or seedling except the fruit;
- "citrus fruit" means the fruit of any citrus tree.
- 3. The following provisions shall have effect in respect of any area declared by the Governor to be infested with the insect known as Mussel Scale (*Lepidosaphes beckii*, Newm.):—
  - (a)—(i) All or any citrus trees shall be fumigated, sprayed or treated in any other manner as the Director of Agriculture may require and within such time as he shall appoint;
  - (ii) All treatment as required in sub-paragraph (i) hereof shall be carried out by the owner or occupier of the trees and at his expense;
