THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1938.

ORDER MADE UNDER SECTION 13.

Whereas at a meeting duly convened and held at the village of Khirokitia, in the District of Larnaca, on the 24th July, 1938, it was determined by the requisite majority of the voters present thereat that a certain area should be reserved as the Tree Planting Area of the village of Khirokitia :

And whereas at the said meeting the boundaries of the said area have been fixed and described :

And whereas the Mukhtar of the village of Khirokitia has forwarded to the Commissioner of the District of Larnaca a report, signed and sealed

by him, containing a description with boundaries of the said area and stating that the said area fulfils the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed :

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Colonial Secretary for the consideration of the Governor :

And whereas the Governor considers it expedient, having regard to all the circumstances, that the area in the said report described should be reserved as the Tree Planting Area of the village of Khirokitia.

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows :-

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Khirokitia in the District of Larnaca.

SCHEDULE.

(a) The boundary commences at the most northern point of plot No. 319 of the Government Survey Plan No. XLIX/53 on a footpath, and proceeds south-eastwards along the said footpath to the road from the village of Vavia to the village of Khirokitia ; thence south-eastwards along the said road to the footpath at the most eastern point of plot No. 44 of the Government Survey Plan No. XLIX/61, locality "Anafandies" ; thence southwards and south-eastwards along the said footpath to the north-eastern corner of plot No. 187 of the said plan, locality "Katiforo," on the village road from the village of Vavla to the main road from Larnaca to Limassol ; thence south-eastwards along the said village road to the said main road ; thence southwards along the said main road to the most southern point of plot No. 599 of the Government Survey Plan No. LV/5, locality "Mavros," on the boundary of the village of Khirokitia ; thence north-westwards along the said village boundary to the most southern point of plot No. 687 of the Government Survey Plan No. XLIX/61, locality "Moutti-tou-Hassou," on the left bank of a stream ; thence north-westwards and northwards along the left bank of the said stream to the most western point of plot No. 15 of the said plan ; thence along the boundaries of, and including, plots Nos. 15, 14, 13 and 30 of the said plan, locality "Sekarethia," plots Nos. 317, 318 and 319 of the Government Survey Plan No. XLIX/53 to the point of commencement.

(b) The boundary commences at the most northern point of plot No. 357, of the Government Survey Plan No. XLIX/53, locality "Anafandies," on the right bank of a river, and proceeds south-eastwards along the right bank of the said river to the south-eastern corner of plot No. 194 of the Government Survey Plan No. XLIX/61 ; thence south-westwards along the boundaries of, and including, plots Nos. 194, 195, 56, 58, 67 and 66 of the said plan, plots Nos. 349, 352, 353, 354, 355 and 357 of the Government Survey Plan No. XLIX/53 to the point of commencement.

The area reserved comprises 1,960 donums approximately and is shown edged red on the plan filed in D.L.R.S. M.P. 546/38.
