THE GOVERNMENT WATERWORKS LAW, 1928.

REGULATIONS MADE UNDER SECTION 34.

REV. S.L. 1943, 8.4.43, p. 145 H. R. PALMER, Governor.

In exercise of the powers vested in him by section 34 of the Government Waterworks Law, 1928, His Excellency the Governor, with the advice of the Executive Council, is pleased to make and hereby makes the following Regulations :--

Gazette : 4.5.1934. 1. These Regulations may be cited as the Government Waterworks (Kafizes) Amendment Regulations, 1938, and shall be read as one with the Government Waterworks (Kafizes) Regulations, 1934, (hereinafter called "the Principal Regulations"), and the Principal Regulations and these Regulations may together be cited as the Government Waterworks (Kafizes) Regulations, 1934 and 1938.

2. The following regulation shall be inserted in the Principal Regulations immediately after regulation 10 thereof :—

"11. No person who makes default in the payment of a rate, payable by him, on or before the 20th day of May in regulation 5 (2) prescribed, shall make use of the water or the waterworks unless and until such person has paid the rate in respect of which default has been made."
