No. 266. Notification under the Tree Planting Village Areas Laws, 1930 to 1936.

XYLIATOS (NICOSIA) FUND.

In exercise of the powers vested in me by the Tree Planting Village Areas Laws, 1930 to 1936, I hereby establish a fund for the village of Xyliatos, in the District of Nicosia (hereinafter called "the Fund"), into which shall be paid all fines recovered under the said Laws for offences committed within the Tree Planting Area of the village of Xyliatos, as described in the Order of the Acting Governor made the 18th day of August, 1938, and published in Supplement No. 3 to the *Gazette* No. 2671 of the 26th August, 1938.

The Fund shall be under the management and control of the Commissioner of Nicosia for the time being.

The money in the Fund shall be utilized for the improvement of arboriculture in the village of Xyliatos.

IRRIGATION DIVISION OF MARATHOVOUNO, CHATOS
AND VITSADHA (KODJADERE).*Rules.*

1. These Rules may be cited as the Irrigation Division of Marathovouno, Chatos and Vitsadha (Kodjadere) Rules, 1938.
2. In these Rules, unless the context otherwise requires:—
 - "Commissioner" means the Commissioner of the District of Famagusta;
 - "Committee" means the Committee of the Irrigation Division;
 - "Irrigation Division" means the Irrigation Division of Marathovouno, Chatos and Vitsadha (Kodjadere).
