**The Municipal Corporations Laws, 1930 to 1938.****BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF NICOSIA.**

In exercise of the powers vested in them by the Municipal Corporations Laws, 1930 to 1938, and otherwise, the Council of the Municipal Corporation of Nicosia hereby make the following Bye-laws:—

1. These Bye-laws may be cited as the Nicosia Municipal (Amendment) Bye-laws, 1938, and shall be read as one with the Nicosia Municipal Bye-laws, 1938, (hereinafter called "the Principal Bye-laws") and the Principal Bye-laws and these Bye-laws may together be cited as the Nicosia Municipal (Principal and Amended Bye-laws), 1938.

2. The following Bye-law shall be substituted for bye-law 188 of the Principal Bye-laws:—

"188. The fee to be paid to the Council in respect of each licence and number-plate for a bicycle or tricycle issued by them shall be one shilling and four and a half piastres."

3. Bye-law 192 of the Principal Bye-laws is hereby amended as follows:—

(a) By the deletion in paragraph 1 (b) thereof of the words "by shooting or".

(b) By the deletion of the Proviso to paragraph (2) thereof.

(c) By the deletion in paragraph (3) thereof of the words "by shooting or".

4. Paragraph (1) of bye-law 202 of the Principal Bye-laws is hereby repealed and the following substituted therefor:—

"(1) There shall be paid by every licensee of an hotel of the 1st, 2nd and 3rd class a fee of one piastre and by every licensee of an hotel of any other class a fee of half a piastre for every person of over 10 years of age in respect of every night or part thereof on which such person is provided with sleeping accommodation at such hotel."

5. Bye-law 203 of the Principal Bye-laws is hereby repealed and the following substituted therefor:—

"(1) There shall be paid to the town clerk and treasurer in every year by any person keeping any of the following places or buildings the fee determined by the Council within the limits set out against each such place or building, that is to say—

(2) There shall be paid to the town clerk and treasurer in every year a fee of 1s. by any person keeping any of the following places or buildings, that is to say,—

- (a) for any kiln ;
- (b) for every oven in a bakery ;
- (c) for any restaurant ;
- (d) for any barber's shop ;
- (e) for any drinking shop ;
- (f) for any pastry shop ;
- (g) for any confectioner's shop ;
- (h) for any pharmacy ;
- (i) for any shoemaker's shop ;
- (j) for any printing office ;
- (k) for any farrier's shop.

(3) The fees in paragraphs (1) and (2) of this bye-law shall be in respect of the period ending on the 31st December of each year irrespective of the time when it becomes chargeable."

6. The Third Schedule to the Principal Bye-laws is hereby repealed and the following Schedule substituted therefor :—

THIRD SCHEDULE.

(Bye-law 173.)

ENTERTAINMENT DUTY.

	<i>Rates</i>
(i) On each ticket the total price of which does not exceed 2p.	0½p.
(ii) On each ticket the total price of which exceeds 2p. but does not exceed 1s. . . . .	1p.
(iii) On each ticket the total price of which exceeds 1s. but does not exceed 2s. . . . .	2p.
(iv) On each ticket the total price of which exceeds 2s. but does not exceed 3s. . . . .	3p.
(v) On each ticket the total price of which is 3s. or over ..	4½p.

The above Bye-laws have been approved by His Excellency the Governor.
