THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

ORDER MADE UNDER SECTION 13.

H. R. PALMER, Governor,

Whereas at a meeting duly convened and held at the village of Kalokhorio (Dagh), in the District of Nicosia, on the 3rd day of October, 1937, it was determined by the voters present thereat that a certain area should be reserved as the Tree Planting Area of the village of Kalokhorio (Dagh):

And whereas at the said meeting the boundaries of the said area have been fixed and described:

And whereas the Mukhtar of the village of Kalokhorio (Dagh) has forwarded to the Commissioner of the District of Nicosia a report, signed and sealed by him, containing a description with boundaries of the said area and stating that the said area fulfils the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed:

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Colonial Secretary for the consideration of the Governor;

And whereas the Governor considers it expedient, having regard to all the circumstances, that the area in the said report described should be reserved as the Tree Planting Area of the village of Kalokhorio (Dagh):

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows:—

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Kalokhorio (Dagh) in the District of Nicosia.

SCHEDULE.

The area lying within the following boundaries, that is to say:—
The boundary begins at the most northern point of plot No. 648 of the Government Survey Plan No. XXXVIII/6, locality "Kilistres," on the right bank of the river "Maroulenas," and goes southwards and south-eastwards passing along the boundaries of, and including in the reserved area, plots Nos. 648, 646, 626, 625, 624, 621, 620 and 615 of the same plan, plots Nos. 481, 483, 489, locality "Azoudhia," plots Nos. 490, 491, 494, 495, 520, 521, 599, 753, 607, 605, 609 and 610 of the Government Survey plan No. XXXVIII/14, locality "Kambos," plots Nos. 155, 157, 158, 159, 149, 148, 159, 174, 175, 176, 166, 165 of the Government Survey plan No. XXXVIII/15, to the most southern point of the latter plot; thence south-westwards and north-westwards, along a ridge, passing along the boundaries of, and including in the reserved area, plots Nos. 665, 716, 668 (across plot No. 674), 671, 672, locality "Phoradas," plots Nos. 655, 657, 656, 305, 307, 308, 301, 314, 315, 317, 328 (across plot No. 329), 333, 343 (across plot No. 360), 361, 363 and 365 of the Government Survey plan No. XXXVIII/14, to

the most southern point of the latter plot, at the top of the right bank of a stream; thence north-westwards along this bank of this stream to the south-western corner of plot No. 406 of the said plan; thence north-westwards and north-eastwards passing along the boundaries of, and including in the reserved area, plots Nos. 406, 411, 412 and 413 to the most western point of plot No. 442 of the said plan, at the top of the right bank of the river "Maroulenas"; thence north-eastwards along this bank of this river to the starting point.

The area reserved comprises 983 donums approximately, as shown edged in red on the plan filed in D.L.R.S. M.P. 526/34.

No. 29. The Irrigation Laws, 1931 and 1934.

In pursuance of the provisions of section 18 of the Irrigation Law, 1931, the following Rules made by the Committee of the Irrigation Division of Mashera Water of Ayios Ioannis, in the District of Limassol, are published in the Gazette.

IRRIGATION DIVISION OF MASHERA WATER OF AYIOS IOANNIS.

Rules.

- 1. These Rules may be cited as the Irrigation Division of Mashera Water of Ayios Ioannis (Amendment) Rules, 1938, and shall be read as one with the Irrigation Division of Mashera Water of Ayios Ioannis Rules, 1933, (hereinafter called "the Principal Rules"), and the Principal Rules and these Rules may together be cited as the Irrigation Division of Mashera Water of Ayios Ioannis Rules, 1933 and 1938.
- 2. Rule 5 of the Principal Rules is hereby repealed and the following Rule substituted therefor:—
 - 5.—Every proprietor mentioned in the list shall pay a rate not exceeding 15s. per annum as may be prescribed by the Committee from time to time, for every Government donum of land, owned by such proprietor which is benefited or is capable of being benefited by the works.
- 3. Rule 7 of the Principal Rules is hereby amended by the insertion immediately after paragraph (d) of the following paragraphs:—
 - (e) for any audit fees;
 - (t) for any costs or expenses incurred in connection with works or proceedings which, in the opinion of the Committee, are beneficial to the Irrigation Division notwithstanding that the same may have been incurred before the formation of the Irrigation Division.
