THE CUSTOMS LAWS, 1936 AND 1937.

ORDER IN COUNCIL No. 1778

MADE UNDER SECTION 59.

H. R. PALMER, Governor.

In exercise of the powers vested in him by section 59 of the Customs Laws, 1936 and 1937, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order and it is hereby ordered as follows:—

- 1. This Order may be cited as the Prohibited Exports (Potatoes) Order, 1938.
- 2. The exportation of potatoes to the United Kingdom between the 30th April, 1938, and the 30th October, 1938, both days inclusive, is prohibited save under the authority of a licence granted by the Director of Agriculture and subject to such terms and conditions as may be prescribed in such licence.

THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

ORDER MADE UNDER SECTION 13.

H. R. PALMER, Governor.

Whereas at a meeting duly convened and held at the village of Mazotos, in the District of Larnaca, on the 19th September, 1937, it was determined by the requisite majority of the voters present thereat that a certain area (hereinafter called "the additional area") should be reserved as a Tree Planting Area of the village of Mazotos in addition to the Tree Planting Area of the village of Mazotos reserved by an Order of His Excellency the Governor and published in the Gazette of the 5th June, 1936, under Notification No. 531, (hereinafter called "the original area"):

And whereas at the said meeting the boundaries of the said additional

area have been fixed and prescribed:

And whereas the Mukhtar of the village of Mazotos has forwarded to the Commissioner of the District of Larnaca a report signed and sealed by him containing a description with boundaries and particulars of the said additional area stating that such area fulfils the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed:

And whereas the said Commissioner has transmitted the said report with his recommendations to the Colonial Secretary for the consideration of the Governor:

And whereas the Governor is satisfied that the original area and the additional area taken together do not comprise in the aggregate more than one-quarter of the total extent of the Arazi Mirié lands situated within the limits of the village of Mazotos:

And whereas the Governor has been pleased to approve the report and considers it expedient, having regard to all the circumstances that the said additional area should be reserved as a Tree Planting Area for the village of Mazotos in addition to the original area:

And whereas the Governor for good cause shown has decided to abridge the period mentioned in section 13 (2) of the Tree Planting Village Areas Laws, 1930 to 1936:

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows:—

- 1. The area prescribed in the Schedule hereto is hereby declared to be and shall be reserved as a Tree Planting Area of the village of Mazotos in the District of Larnaca in addition to the original area.
- 2. The period mentioned in section 13 (2) of the Tree Planting Village Areas Laws, 1930 to 1936, is hereby and shall be abridged to expire on the 5th July, 1946.

SCHEDULE.

The area lying within the following boundaries, that is to say:—

The boundary commences at the most northern point of plot No. 112 of the Government Survey plan No. L/51, locality Xeropouzos," on the right bank of the river "Xeropouzos, and proceeds south-eastwards along this bank of this river to the most eastern point of plot No. 157 of the Government Survey plan No. L/52, at which point a road crosses the river over a bridge; thence south-westwards along this road to the cross-roads at the most southern point of plot No. 44 of the Government Survey plan No. L/60; thence north-westwards along another road leading to the village of Mazotos to the most southern point of plot No. 20 of the Government Survey plan No. L/59, locality "Pano Livadhia"; thence northwards passing along the boundaries of, and including in the reserved area, plot No. 20 of the said plan, plots Nos. 430, 316, 307, 306, 222, 179, 180, 161, 162 and 112 of the Government Survey plan No. L./51 to the point of commencement.

The area reserved comprises 1,132 donums approximately, as shown edged in red on the plan filed in D.L.R.S. M.P. 234/35.
