

**No. 38. THE BURIALS LAWS, 1896 AND 1937.****ORDER MADE UNDER SECTION 1.**

Whereas the burial-ground situated in the village of Yerakies, District of Nicosia, now in use by the Orthodox-Christian Community for the burial of the dead, is dangerous to the health of the said village :

Now, therefore, in exercise of the powers vested in him by section 1 of the Burials Laws, 1896 and 1937, His Excellency the Governor has been pleased to order and hereby orders that a new burial-ground, in substitution for the burial-ground now in use as aforesaid, shall be provided under the provisions of the said Laws.

**No. 39. THE BURIALS LAWS, 1896 AND 1937.****ORDER MADE UNDER SECTION 14.**

Whereas in pursuance of Notification No. 215, published in Supplement No. 3 to the *Gazette* of the 3rd December, 1937, a fit and proper site has been registered in the books of the Land Registry Office as a burial-ground for the burial of the dead by the Moslem Community of the village of Phinikas, in the District of Paphos :

Now, therefore, in exercise of the powers vested in him by section 14 of the Burials Laws, 1896 and 1937, His Excellency the Governor has been pleased to order and hereby orders that, from and after the 1st day of April, 1938, no burial shall take place in the burial-ground in lieu whereof the new burial-ground above referred to has been provided.

**No. 40. Notification under the Tree Planting Village Areas Laws, 1930 to 1936.****KALOKHORIO (DAGH) (NICOSIA) FUND.**

In exercise of the powers vested in me by the Tree Planting Village Areas Laws, 1930 to 1936, I hereby establish a fund for the village of Kalokhorio (Dagh), in the District of Nicosia (hereinafter called "the Fund"), into which shall be paid all fines recovered under the said Laws for offences committed within the Tree Planting Area of the village of Kalokhorio (Dagh), as described in the Order of the Governor made the 16th of February, 1938, and published in Supplement No. 3 to the *Gazette* No. 2635 of 18th February, 1938.

The Fund shall be under the management and control of the Commissioner of Nicosia for the time being.

The money in the Fund shall be utilized for works of public utility in the village of Kalokhorio (Dagh).
