THE TROODOS PUBLIC HEALTH LAWS, 1920 TO 1936.

ORDER IN COUNCIL No. 1780

MADE UNDER SECTION 3.

H. R. PALMER,

Governor.

In exercise of the powers vested in him by section 3 of the Troödos Public Health Laws, 1920 to 1936, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order and it is hereby ordered as follows :--

1. This Order may be cited as the Troödos Public Health Order, 1938.

2. The area set out in the Schedule hereto shall be and is hereby declared to be a sanitary area for the purposes of the Law.

3. There shall be constituted a Public Health Board for the supervision and control of the sanitation of the sanitary area consisting of such persons as the Governor may by notice appoint, one of whom shall be Chairman :

Provided that the Board as constituted by the notice published in the Gazette of the 22nd May, 1936, under Notification No. 492 shall continue in office until such time as other provision shall be made in that behalf.

4. The Board shall meet at such times and at such places as the Chairman shall direct.

5. Minutes of the proceedings of every meeting of the Board shall be drawn up correctly and entered in a book kept for that purpose and shall be signed by the Chairman.

6. The accounts relating to the sanitary area shall be kept by such person as the Board may appoint to act as Treasurer of the Board.

7. The Orders in Council No. 798 and No. 1691 published in the Gazettes of the 30th June, 1920, and the 22nd May, 1936, respectively, are hereby revoked without prejudice to anything done thereunder.

SCHEDULE.

The Sanitary Area of Troödos.

The area lying within the following boundaries, that is to say :----The boundary begins at the boundary stone marked S.A. I, situated on the north side of the main road from Troödos to Platres about 38 yards south of Government hut No. 13, and goes northwestwards along this road for a distance of about 560 yards to the boundary stone marked S.A.2, situated on the south side of the road (Jubilee Road), about 200 yards west of Government hut No. 1; thence north-eastwards in a straight line for a distance of about 600 yards to the boundary stone marked S.A. 3, situated about 80 yards west of the Government triangulation point No. C/4, locality "Mouvies"; thence north-castwards in a straight line for a distance of about 966 yards to the boundary stone marked S.A.4, situated about 70 yards north-east of the Government triangulation point No. D/4, at the summit of the hill due west of the Troödos Government Club; thence north-eastwards in a straight line for a distance of about 1,243 yards to the boundary stone marked S.A. 5, situated in the bed of a stream about 170 yards south-west of the Government triangulation point No. 936/4; thence north-eastwards in a straight line for a distance of about 176 yards to the boundary stone marked S.A.6, situated on a footpath from Troödos to Mt. Olympus, about 50 yards south-east of the Government triangulation point No. 936/4; thence south-eastwards and north-eastwards down the valley of a stream, a tributary of the stream "Koutsalas" for a distance of about 1,083 yards to the boundary stone marked S.A.7, at the junction of this stream with the stream from "Kannoures" springs; thence eastwards in a straight line for a distance of about 850 yards to the boundary stone marked S.A. 8, situated about 13 yards northwest of the Government triangulation point No. 939/4; thence south-eastwards in a straight line for a distance of about 250 yards to the boundary stone marked S.A. 9, situated at the north-eastern corner of the fencing round the "Pasha Livadhi" garden; thence south-eastwards in a straight line for a distance of 475 yards to the boundary stone marked S.A. 10, situated on a track leading to the main road from Nicosia to Troödos; thence south-westwards along this track to the said main road and crossing the main road, down the stream which flows into the stream " Loumata," to the boundary stone S.A. 11, situated at the confluence of the two said streams; thence south-westwards in a straight line for a distance of about 1,820 yards to the boundary stone marked W.D. 32, situated about 70 yards south-west of a footpath from the Military Camp to Mesapotamos Monastery and about 20 yards west of the Government triangulation point K/4; thence south-westwards in a straight line for a distance of about 1,120 yards to the boundary stone marked S.A. 12, situated about 100 yards south-west of Government hut No. 5; thence south-westwards in a straight line for about 840 yards to the starting point.

The area is shown edged in red on the plan filed in D.L.R.S. M.P. 593/35.
