**THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.**

ORDER MADE UNDER SECTION 13.

Whereas at a meeting duly convened and held at the village of Gourri, in the District of Nicosia, on the 19th day of December, 1937, it was determined by the requisite majority of the voters present thereat that two areas should be reserved as the Tree Planting Area of the village of Gourri :

And whereas at the said meeting the boundaries of the said areas have been fixed and described :

And whereas the Mukhtar of the village of Gourri has forwarded to the Commissioner of the District of Nicosia a report, signed and sealed by him, containing a description with boundaries of the said areas and stating that the said areas fulfil the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed :

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Colonial Secretary for the consideration of the Governor :

And whereas the Governor considers it expedient, having regard to all the circumstances, that the areas in the said report described should be reserved as the Tree Planting Area of the Village of Gourri.

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows :—

The areas described in the Schedule hereto are hereby declared to be and shall be reserved as the Tree Planting Area of the village of Gourri in the District of Nicosia.

SCHEDULE.

The areas lying within the following boundaries, that is to say :—

*Area No. 1 :*

The boundary begins at Forest Cairn No. 7 of the " Askopelos " Forest, on the boundary of the village of Gourri, and goes eastwards and south-eastwards along this village boundary to the most eastern point of plot No. 299 of the Government Survey plan No. XXXVIII/22, locality " Ayia Paraskevi " ; thence southwards and westwards along the eastern and southern boundaries of the said plot to a tributary of the river " Pharmakas " ; thence westwards down this stream to its junction with the river " Pharmakas " ; thence south-westwards along the right bank of the said river to the most southern point of plot No. 252 of the said plan, at which point it is joined by another stream ; thence south-westwards up this stream to the north-western corner of plot No. 188 of the said plan, locality " Phelladhes " ; thence north-westwards along the western boundary of plot No. 189 of the said plan to the footpath running through this plot ; thence south-westwards and north-westwards along this footpath to the north-eastern corner of plot No. 163 of the said plan, locality

“Souroujis”; thence south-westwards passing along the boundaries of, and including in the reserved area, plots Nos. 163 of the said plan, 136, 130 and 126 of the Government Survey plan No. XXXVIII/30, to the most southern point of plot No. 126, on the boundary of the village of Gourri; thence northwards along this village boundary through the localities “Askopelos” and “Moutti-tou-Karamaniti” to the point in which it meets the forest delimitation line of the “Askopelos” Forest; thence south-eastwards and north-eastwards along this forest delimitation line through Forest Cairns Nos. 2, 3, 4, 5 and 6 to the starting point.

*Area No. 2 :*

The boundary begins at the most northern point of plot No. 126 of the Government Survey plan No. XXXVIII/23, on the boundary of the village of Gourri, and goes eastwards and southwards along this village boundary through the localities “Latsieri” and “Moutti-tis-Latsieris” to the south-eastern corner of plot No. 103 of the Government Survey plan No. XXXVIII/31; thence westwards passing along the boundaries of, and including in the reserved area, plots Nos. 103, 102, 98, 96, 100, 77, 62, 64, 75 and 72 of the said plan, plots Nos. 325, 326, 324, 329, 330, 315, 314, 298, 300 and 301 of the Government Survey plan No. XXXVIII/30, to the most western point of plot No. 301, on a track leading to the village of Kalokhorio; thence north-eastwards along this track to the starting point.

The areas reserved comprise 2,544 donums approximately, as shown edged in red on the plan filed in D.L.R.S. M.P. 610/37.

**No. 68. THE BURIALS LAWS, 1896 AND 1937.**

ORDER MADE UNDER SECTION 1.

Whereas the burial-ground situated in the village of Phterykoudhi, District of Nicosia, now in use by the Orthodox-Christian Community for the burial of the dead, is dangerous to the health of the said village :

Now, therefore, in exercise of the powers vested in him by section 1 of the Burials Laws, 1896 and 1937, His Excellency the Governor has been pleased to order and hereby orders that a new burial-ground, in substitution for the burial-ground now in use as aforesaid, shall be provided under the provisions of the said Laws.
