

*Bubulina Street (Part of) :*

The area of land varying in width from 30 to 32 feet wide and 552 feet long approximately which commences at the point at which Bubulina Street crosses Stassandrou Street being bounded on the west by plots Nos. 193, 193/6, 364 and 193/9 of Block No. 25, Nicosia Town (Government Survey Plan No. XXI.54.3.I) and on the east by plots Nos. 191/5 and 191/8, 191/6, 191/6/1, 191/6/2, 191/6/3 and 191/6/4, Block No. 25, Nicosia Town (Government Survey Plan No. XXI.54.3.I), more particularly defined as the area coloured blue and marked G-H on the Government Survey Plan Serial No. 1170, a copy of which has been deposited in the office of the Director of Land Registration and Surveys.

*Kypranoros Street :*

The area of land 30 feet wide and 776 feet long approximately which commences at the junction of Kypranoros Street and Stassandrou Street being bounded on the west by plots Nos. 201/1, 201/1/1, 201/2, 201, 201/3, 201/4, 201/5 and 200, Block No. 25, Nicosia Town (Government Survey Plan No. XXI.54.3.I) and on the east by plots Nos. 202, 281, 203/2, 203/4, 203, 203/3/2 and 203/3/1, Block No. 25, Nicosia Town (Government Survey Plan XXI.54.3.I), more particularly defined as the area coloured blue and marked J-K on the Government Survey Plan Serial No. 1170, a copy of which has been deposited in the office of the Director of Land Registration and Surveys.

**THE CONSTRUCTION OF BUILDINGS, STREETS AND WELLS  
ON ARAZI MIRIE LAWS, 1927 TO 1938.**

**ORDER UNDER SECTION 8 (4).**

Whereas the area of the land of the Arazi Mirié category situated in the Tripioti Quarter within the municipal limits of the town of Nicosia described in the Schedule hereto has been set aside with the approval of the Building Committee for the Municipal Area of the town of Nicosia for use as a street ;

And whereas, on account of the number of buildings erected on the frontage of such land, the said Building Committee has considered that such street should be properly constructed and has forwarded a report in writing to this effect to the Colonial Secretary ;

Now, therefore, in exercise of the powers vested in the Governor by section 8 (4) of the Construction of Buildings, Streets and Wells on Arazi Mirié Laws, 1927 to 1938, His Excellency the Acting Governor has been pleased to order and it is hereby ordered that the land so set aside shall be constructed as a street by or under the supervision of the Municipal Corporation of Nicosia and that the cost of such construction shall be borne by the owners of plots or buildings adjacent to such street in proportion to the length of frontage of each plot or building to the length of the street in accordance with the provisions of the said Laws.

## SCHEDULE.

*Arnalda Street :*

The area of land 20 feet wide and 445 feet long approximately which commences at the junction of Arnalda Street with Stassinou Road being bounded on the west by plots Nos. 301, 302, 150/1, 150 and 150/2 of Block No. 25, Nicosia Town (Government Survey Plan No. XXI.46.5.IV, and on the east by plots Nos. 152, 195, 221, 222 and 224 of Block No. 25, Nicosia Town (Government Survey Plans Nos. XXI.46.5.IV and XXI.54.2.II), more particularly defined as the area coloured blue and marked A-B on the Government Survey Plan Serial No. 1170, a copy of which has been deposited in the office of the Director of Land Registration and Surveys.
