## THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

## ORDER MADE UNDER SECTION 13.

Whereas at a meeting duly convened and held at the village of Pharmakas, in the District of Nicosia, on the 8th day of January, 1939, it was determined by the voters present thereat that a certain area should be reserved as the Tree Planting Area of the village of Pharmakas.

And whereas at the said meeting the boundaries of the said area have been fixed and described :

And whereas the Mukhtar of the village of Pharmakas has forwarded to the Commissioner of the District of Nicosia a report, signed and sealed by him, containing a description with boundaries of the said area and stating that the said area fulfils the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed :

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Acting Colonial Secretary for the consideration of the Acting Governor :

And whereas the Acting Governor considers it expedient, having regard to all the circumstances, that the area in the said report described should be reserved as the Tree Planting Area of the village of Pharmakas.

Now, therefore, His Excellency the Acting Governor, in exercise of the powers vested in the Governor by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows :—

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Pharmakas, in the District of Nicosia.

## SCHEDULE.

The area lying within the following boundaries, that is to say :—

The boundary commences at the most western point of plot No. 29 of the Government Survey Plan No. XXXVIII/46, locality "Kapsali," which point is on the boundary of the village of Pharmakas, and proceeds along the said village boundary, northwards through the localities "Paleokamina," "Mutoyephyra" and "Athasia tou Kapitanou," southwards through the localities "Jafferis," "Ayios Dhimitrios," "Kambos" and "Lakhappidhima" to the most western point of plot No. 602 of the said plan, locality "Yerakia"; thence westwards along the southern boundary of plot No. 363 of the said plan to the right bank of the river "Kremnistra"; thence due westwards across the said river to its left bank; thence southwards along the left bank of the said river to the stream in plot No. 222 of the said plan; thence westwards up the said stream to the south-eastern corner of plot No. 225 of the said plan, at which point a footpath leaves the road from the village of Pharmakas to the village of Kalokhorio; thence north-westwards along the said footpath to the most southern point of plot No. 144 of the said plan, at which point it is joined by another footpath; thence north-westwards along that footpath bounding plots Nos. 144, 142, 137, 138 and 30 of the said plan to the point of commencement, all which said boundary includes 2,405 donums or thereabouts, as shown edged in red on the plan filed in D.L.R.S. M.P. 733/34.
