SUBSIDIARY LEGISLATION.

BY THE ACTING GOVERNOR.

A PROCLAMATION.

A. B. WRIGHT,

Acting Governor.

Whereas it is expedient to amend the boundaries of the villages of Paleokhorio (Dagh) and Apliki, in the District of Nicosia:

Now, therefore, in exercise of the powers vested in the Governor by the Village Authorities Laws, 1931 to (No. 2) 1937, and otherwise, I, Andrew Barkworth Wright, Commander of the Most Excellent Order of the British Empire, on whom has been conferred the Decoration of the Military Cross, Acting Governor and Commander-in-Chief in and over the Colony of Cyprus, do hereby order and proclaim that from and after the 1st day of July, 1939, the area described in the Schedule hereto, heretofore reckoned within the boundaries of the village of Paleokhorio (Dagh), shall form part of the lands of the village of Apliki and that the boundaries of the said villages of Paleokhorio (Dagh) and Apliki shall be altered accordingly.

SCHEDULE.

Area transferred from the Village Lands of Paleokhorio (Dagh) to the Village Lands of Apliki:

The boundary of the area commences at the most western point of plot No. 164 of the Government Survey plan No. XXXVIII/53, locality "Moutti-tou-Majita," on a footpath, and proceeds north-eastwards and south-eastwards along the boundaries of and including, plots Nos. 164, 163, 162, 189 and 204 of the said plan to the north-eastern corner of the said plot No. 204, on the left bank of the river "Maroulena"; thence southwards along the left bank of the said river to its junction with the river "Kambiou"; thence south-eastwards along the left bank of the latter river to the most southern point of plot No. 250 of the said plan, locality "Ayios Reginos"; thence south-westwards along the boundaries

of, and including plots Nos. 250, 359, 360, 365, 366, 367, 368, 370, 371, 372, 648.1, 374 and 375 to the most northern point of plot No. 377 of the said plan, which point is on the right bank of the river "Maroulena"; thence westwards along the right bank of this river to the north-western corner of plot No. 432 of the said plan; thence due westwards crossing the river "Maroulena" to the south-eastern corner of plot No. 438 of the said plan; thence westwards and north-eastwards along the boundaries of, and including, plots Nos. 438, 442, and 441 to the most northern point of plot No. 441 of the said plan, on the main road from Nicosia to Paleokhorio; thence south-eastwards and north-eastwards along this main road to the most western point of plot No. 185 of the said plan; thence north-eastwards along the boundaries of, and including, plots Nos. 185, 187 and 164 of the said plan to the point of commencement, all which boundary includes 186 donums or thereabouts, as shewn coloured yellow on the plan filed in D.L.R.S. M.P. 236/38.

THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

ORDER MADE UNDER SECTION 13.

Whereas at a meeting duly convened and held at the village of Kouka, in the District of Limassol, on the 2nd day of October, 1938, it was determined by the voters present thereat that a certain area should be reserved as the Tree Planting Area of the village of Kouka.

,... And whereas at the said meeting the boundaries of the said area have been fixed and described:

And whereas the Mukhtar of the village of Kouka has forwarded to the Commissioner of the District of Limassol a report, signed and sealed by him, containing a description with boundaries of the said area and stating that the said area fulfils the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed:

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Acting Colonial Secretary for the consideration of the Acting Governor:

And whereas the Acting Governor has decided to limit the area in the said report described:

Now, therefore, His Excellency the Acting Governor, in exercise of the powers vested in the Governor by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows:—

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Kouka, in the District of Limassol.
