SUBSIDIARY LEGISLATION.

No. 163. THE BURIALS LAWS, 1896 AND 1937.

ORDER MADE UNDER SECTION 1.

Whereas the burial-ground situated in the village of Menoyia, in the District of Larnaca, now in use by the Moslem Community for the burial of the dead, is insufficient for the requirements and dangerous to the health of the said village :

Now, therefore, in exercise of the powers vested in the Governor by section 1 of the Burials Laws, 1896 and 1937, His Excellency the Acting Governor has been pleased to order and hereby orders that a new burial-ground, in substitution for the burial-ground now in use as aforesaid, shall be provided under the provisions of the said Laws.

THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

ORDER MADE UNDER SECTION 13.

Whereas at a meeting duly convened and held at the village of Evrykhon, in the District of Nicosia, on the 16th day of April, 1939, it was determined by the voters present thereat that a certain area should be reserved as the Tree Planting Area of the village of Evrykhon.

And whereas at the said meeting the boundaries of the said area have been fixed and described :

And whereas the Mukhtar of the village of Evrykhon has forwarded to the Commissioner of the District of Nicosia a report, signed and sealed by him, containing a description with boundaries of the said area and stating that the said area fulfils the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed :

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Acting Colonial Secretary for the consideration of the Acting Governor :

And whereas the Acting Governor considers it expedient, having regard to all the circumstances, that the area in the said report described should be reserved as the Tree Planting Area of the village of Evrykhon.

Now, therefore, His Excellency the Acting Governor, in exercise of the powers vested in the Governor by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows :—

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Evrykhon, in the District of Nicosia.

SCHEDULE.

The area lying within the following boundaries, that is to say :—

The boundary commences at the most northern point of plot No. 146, of the Government Survey Plan No. XXVIII/53, locality "Anephani," on the eastern side of the main road from Nicosia to Tröodos and proceeds south-eastwards along the boundaries of, and including, plots Nos. 146, 145, 144, 58 and 128 of the said plan, to the most eastern point of the last-mentioned plot, which point is on the road from the village of Ayios Theodoros to the village of Evrykhon ; thence south-eastwards along the said road to the most eastern point of plot No. 123 of the said plan, locality "Shilleri," on the boundary of the village of Evrykhon ; thence south-westwards along the boundary of the village of Evrykhon to Forest Cairn No. 255 of the Adelphi Forest ; thence north-westwards along the forest delimitation line through Forest Cairns Nos. 256, 257, 258, 259, 260 and 261 to Forest Cairn No. 262 of the said forest on the boundary of the village of Evrykhon ; thence north-westwards along the said village boundary to the main road from Nicosia to Tröodos ; thence north-eastwards along the said main road to the most northern point of plot No. 95 of the Government Survey plan No. XXVIII/53, locality "Appies" on a footpath ; thence south-eastwards along the said footpath to the most western point of plot No. 106 of the said plan ; thence north-eastwards and north-westwards along the boundaries of and including plots Nos. 106, 89, 87, 88 and 66 of the said plan to the north-western corner of the last-mentioned plot, locality "Reximon" which point is on the main road from Tröodos to Nicosia ; thence north-eastwards along the said main road to the point of commencement, all which area is 1,665 donums or thereabouts, as shown edged in red on the plan filed in D.L.R.S. M.P. 171/39.
