THE CHANGE OF TITLES LAW, 1934. No. 180.

> ORDER IN COUNCIL No. 1874 MADE UNDER SECTION 4.

THE ELEMENTARY EDUCATION LAWS, 1933 TO (No. 2) 1937.

REGULATIONS MADE UNDER SECTION 5.

Governor.

In exercise of the powers vested in him by section 5 of the Elementary Education Laws, 1933 to (No. 2) 1937, His Excellency the Governor is pleased to make and hereby makes the following Regulations:—

1. These Regulations may be cited as the Elementary Education (Classification and Promotion of Teachers) Regulations, 1939.

- 2. In these Regulations, unless the context otherwise requires,—
 - "Law" means the Elementary Education Laws, 1933 to (No. 2) 1937, and includes any regulations made thereunder and relating to the qualifications of teachers;
- "Register" means the Permanent Staff Register required to be kept by the Director under the provisions of section 32 of the Law;
- "Temporary Staff Register" means the Temporary Staff Register required to be kept by the Director under the provisions of section 37 of the Law.
- 3. Teachers on the Register shall be classified by the Director into four classes, namely, first, second, third and fourth.
- 4. The Register shall comprise the four classes of teachers in regulation 3 hereof mentioned, and the name and surname of each teacher in each class shall be recorded by the Director or by his direction in the appropriate class in the Register.
- 5.—(1) Persons registered on the Temporary Staff Register and possessing the qualifications prescribed by the Law may at any time be registered by the Director in the fourth class of the Register according to the number of vacancies in that class and according to the requirements of the service.
- (2) Where any person is appointed by the Director to serve on probation in the fourth class the registration of such person in that class shall not constitute such person a fourth class teacher unless and until his registration in that class shall have been confirmed by the Director.
- 6.—(1) Teachers on the Register who possess the qualifications prescribed by the Law may at any time be promoted by the Director from one class to another according to the number of vacancies in each class and according to the requirements of the service.
- (2) Where any teacher of any class on the Register is appointed by the Director to serve on probation in any higher class the registration of such teacher in such higher class shall not constitute such teacher a teacher of such higher class unless and until his registration in such higher class shall have been confirmed by the Director.
- 7. When any person or teacher has been appointed by the Director to serve on probation in any class, the Director may at any time confirm the registration or classification of such person or teacher in the class in which he is serving on probation, notwithstanding that such person or teacher may not have complied with the requirements of any regulations for the time being in force prescribing the qualifications for teachers for such class if such regulations were made or brought into force after the date upon which such person or teacher was so appointed on probation.
- 8. When any person or teacher has been appointed by the Director to serve on probation in any class, and his classification or registration in such class has not been confirmed by the Director as in regulation 7 provided, the Director may at any time cancel such probationary classification or registration notwithstanding that such person or teacher possesses all the qualifications prescribed by the Law for the class in which he was appointed on probation.

- 9. Save as in regulation 7 provided no teacher who was registered on or before the 25th day of August, 1937, in the second or third class of the Register shall be promoted to any higher class thereof unless, in addition to possessing all other qualifications which may be required by the Law, he has passed the Ordinary Examination in English or another examination considered by the Director to be the equivalent thereof.
- 10. No person shall hereafter be registered as a teacher in the fourth class of the Register, and no teacher who has been registered on or after the 25th day of August, 1937, in the fourth class of the Register shall be promoted to the third or any higher class thereof unless, in addition to possessing all other qualifications which may be required by the Law, he has passed the Distinction Examination in English or another examination considered by the Director to be the equivalent thereof.
- 11. The Elementary Education (Classification and Promotion of Gazette: Teachers) Regulations, 1937, are hereby revoked, without prejudice to anything done or left undone thereunder.
