THE GAME AND WILD BIRDS LAWS, 1934 AND 1938.

ORDER IN COUNCIL No. 1876

MADE UNDER SECTION 15.

W. D. BATTERSHILL,

Governor.

In exercise of the powers vested in him by section 15 of the Game and Wild Birds Laws, 1934 and 1938, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order and it is hereby ordered as follows :—

1. This Order may be cited as the Temporary Game Reserve Areas Order, 1939.

2. The areas specified in the Schedule hereto shall be and are hereby declared to be Temporary Game Reserve areas for the period between the 11th day of September, 1939, and the 10th day of September, 1940, both days inclusive.

SCHEDULE.

Area No. 1 (partly in Nicosia District and partly in Kyrenia District):

The boundary commences at the fork of roads about one mile north-west of the village of Myrtou at which the main road to Nicosia *via* Myrtou leaves the main road from Lapithos to Morphou and goes south-eastwards along the former main road to the village of Ayios Vasilios; thence southwestwards along the road to the village of Philia up to the river "Ovghos"; thence north-westwards along this river to the road from the village of Kyra to the village of Kalokhorio (Kapouti); thence along the road to the latter village; thence north-eastwards along the main road from Morphou to the point of commencement.

Area No. 2 (partly in Nicosia District and partly in Limassol District) :

The boundary commences on the main road from Troödos to Nicosia at the point at which it is joined by the road from the village of Vizakia about two miles south-west of the village of Astromeritis and goes northeastwards along the said main road through the latter village and the village of Peristerona to the point at which the road to the village of Orounda leaves the main road, about one mile east of the village of Peristerona; thence southwards along the village road to the village of Orounda and through the latter village and the villages of Kato Moni, Alithinou, Livadhia, Polystipos and Khandria to the main road from Paleokhorio to the locality "Karvounas"; thence westwards along the latter road to the locality "Karvounas" on the main road from Troödos to Nicosia; thence northwards along the latter road to the point at which the road to the village of Spilia leaves the main road near mile post No. 40; thence eastwards and northwards along the village road through the villages of Spilia, Kourdhali, Ayia Irini, Kannavia and Vizakia to the point of commencement.

Area No. 3 (Nicosia District) :

The boundary commences on the main road from Paleokhorio to Nicosia at the turning to the village of Aradhiou and goes eastwards along the road, through this village to the village of Episkopio; thence southwards along the road through the village of Pera to the village of Kapedhes; thence south-westwards along the road, to the Makheras Monastery; thence north-westwards along the track to the village of Lazania; thence north-westwards along the road through the villages of Gourri and Kalokhorio to the main road from Paleokhorio to Nicosia; thence northeastwards along this main road the point of commencement.

Area No. 4 (partly in Nicosia District and partly in Larnaca District):

The boundary commences on the village road from Alambra to Lymbia at the point at which it crosses the main road from Nicosia to Limassol and proceeds eastwards along the said village road to the village of Lymbia; thence southwards along the direct footpath from Lymbia to Psevdhas; thence south-eastwards down the stream "Tremithios" to the point at which it crosses the main road from Larnaca to Limassol; thence southwestwards along the said main road to the point at which it is crossed by the stream "Pouzis"; thence north-westwards up the said stream to the point at which it crosses the village road from Stavrovouni Monastery to the main road from Limassol to Nicosia; thence north-westwards along the said village road to the said main road; thence north-wards along the said main road to the point of commencement.

Area No. 5 (Kyrenia District):

The boundary commences on the main road from Kyrenia to Ayios Amvrosios at the point where it is joined by the road from the village of Klepini, and proceeds south-eastwards along the latter road to the point where it crosses the Ayios Epiktitos-Klepini village boundary at the bridge over the stream known as "Arvili" or "Vordonospastis"; thence south-westwards along the said village boundary to the point where it crosses the Buffavento Forest Delimitation Line between Cairns Nos. 9A and 9; thence westwards along the said Forest Delimitation Line to Cairn No. 6; thence north-westwards along the Ayios Epiktitos-Bellapais village boundary to Cairn No. 32 of the Dhikomo and Bellapais (Kipolistro) Forest; thence westwards along the said village boundary to the point where it joins the stream known as "Dramias" or "Kafkallia"; thence north-eastwards down this stream to the point near Ayios Nikolaos ruined church where the villages of Ayios Epiktitos, Bellapais and Kazaphani form a common boundary; thence northwards along the Ayios Epiktitos-Kazaphani village boundary to the point where it crosses the main road from Kyrenia to Ayios Amvrosios; thence eastwards along the said road to the point of commencement.

Area No. 6 (Larnaca District):

The whole of Xylotymbou Forest together with Block No. 1 of Ormidhia Forest (situated to the north-west of the village of Ormidhia between the roads from the village of Ormidhia to the village of Xylotymbou and Akhna) and Block No. 2 of Ormidhia Forest (situated to the east of the village of Ormidhia between the roads from the village of Ormidhia to the villages of Avgorou and Xylophagou).

Area No. 7 (Famagusta District):

The boundary commences at the point at which the road from Ayios Theodhoros to Vokolidha leaves the main road from Famagusta to Rizokarpaso and proceeds north-eastwards along the said road to Vokolidha; thence south-eastwards to the seashore, along the track through the locality "Livadhia"; thence south-westwards along the seashore to the jetty at Boghaz; thence due northwards to the main road from Famagusta to Rizokarpaso; thence north-eastwards along the eastern side of the said main road to the point of commencement.

Area No. 8 (Famagusta District):

The boundary commences at Rizokarpaso and goes south-eastwards along the southern side of the main road to Khelones on the seashore; thence south-westwards along the seashore to the point due south of Neta; thence due northwards to Neta; thence north-westwards along the north-eastern side of the road to Vathylakkas; thence north-eastwards along the southern side of the old main road through Ayios Symeon and Korovia to the point of commencement.

Area No. 9 (Limassol District) :

The boundary commences at the point at which the main road from Paphos to Limassol crosses the right bank of the river "Paramali" and proceeds eastwards along the southern side of this road to the left bank of the river "Symboulos"; thence southwards along the left bank of the said river to the seashore; thence westwards along the seashore to the mouth of the river "Paramali"; thence northwards along the right bank of the said river to the point of commencement.

Area No. 10 (Limassol District):

The boundary commences at Forest Cairn No. 2B of "Randi" Forest where the main road from Paphos to Limassol crosses the eastern forest delimitation line of the said forest and proceeds eastwards along the southern side of the said main road to the stream "Arghaki tou Alykou"; thence southwards along the left bank of the said stream to the seashore; thence westwards along the seashore to the eastern forest delimitation line of "Randi" Forest; thence northwards along the said forest delimitation line to the point of commencement. Area No. 11 (Limassol District):

The boundary commences at the point at which the old main road from Limassol to Perapedhi leaves the existing main road (between mile posts Nos. 18 and 19) and proceeds north-westwards along the eastern side of the said old main road through Kouka to join the existing main road east of Perapedhi; thence eastwards and southwards along the southern and western side of the existing main road through Trimiklini to the point of commencement.
