THE ELEMENTARY EDUCATION LAWS, 1933 TO (No. 2) 1937.

ORDER MADE UNDER SECTION 74 (1).

In exercise of the powers vested in him by section 74 (1) of the Elementary Education Laws, 1933 to (No. 2) 1937, and otherwise, His Excellency the Governor is pleased to order and hereby orders that the tax mentioned in section 65 of the said Laws payable by the Maronite tax-payers of the villages mentioned in the first column of the Schedule hereto shall be increased by the rate per thousand mentioned in the second column of the said Schedule hereto to provide the amount for the payment of loans or annual maintenance of the Maronite Schools of the said villages respectively.

No. 187. THE BURIALS LAWS, 1896 AND 1937.

Whereas in pursuance of Notification No. 136 published in Supplement No. 3 to *Gazette* No. 2595 of the 9th July, 1937, a fit and proper site has been registered in the books of the Land Registry Office as a burial-ground for the burial of the dead by the Orthodox-Christian Community of the village of Gourri, in the District of Nicosia :

Now, therefore, in exercise of the powers vested in him by section 14 of the Burials Laws, 1896 and 1937, His Excellency the Governor has been pleased to order and hereby orders that, from and after the 4th day of September, 1939, no burial shall take place in the burial-ground in lieu whereof the new burial-ground above referred to has been provided.

No. 188. THE LAND ACQUISITION LAWS, 1899 TO 1936.

NOTIFICATION UNDER SECTIONS 2, 3 AND 4.

Whereas it has been represented to me that it is desirable in the public interest to erect premises in the Mahmoud Pasha Quarter of the Town of Nicosia, for use as residence of the Commissioner of the District of Nicosia :

Now, therefore, I, William Denis Battershill, Companion of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Colony of Cyprus, by virtue of the powers vested in me by sections 2, 3 and 4 of the Land Acquisition Laws, 1899 to 1936, do hereby declare the erection of premises as aforesaid for the purpose aforesaid, to be an undertaking of public utility, and do hereby authorize the carrying out of the said undertaking, and do hereby entrust to the Director of Public Works the supervision and effectuation of the said undertaking.

**No. 189. Notification under the Tree Planting Village Areas
Laws, 1930 to 1936.**

EVRYKHOU (NICOSIA) FUND.

In exercise of the powers vested in me by the Tree Planting Village Areas Laws, 1930 to 1936, I hereby establish a fund for the village of Evrykhon, in the District of Nicosia (hereinafter called "the Fund"), into which shall be paid all fines recovered under the said Laws for offences committed within the Tree Planting Area of the village of Evrykhon, as described in the Order of the Governor made the 1st day of August, 1939, and published in Supplement No. 3 to the *Gazette* No. 2740 of the 4th August, 1939.

The Fund shall be under the management and control of the Commissioner of Nicosia for the time being.

The money in the Fund shall be utilized for the improvement of arboriculture in the village of Evrykhon.
