No. 212. THE CUSTOMS LAWS, 1936 TO (No. 2) 1938.

ORDER IN COUNCIL No. 1879

MADE UNDER SECTION 59.

W. D. BATTERSHILL,
Governor.

In exercise of the powers vested in him by section 59 of the Customs Laws, 1936 to (No. 2) 1938, His Excellency the Governor, with the advice of the Executive Council, is pleased to order and it is hereby ordered as follows:—

1. This Order may be cited as the Exportation of Goods (Restriction) Order, 1939.
2. From and after the date of the publication of this Order in the *Gazette*, every exporter of any goods to be shipped from the Colony shall, prior to the shipment of such goods, furnish the proper Officer of Customs at the port of exportation with a declaration of ultimate destination in the form set out in the Schedule hereto.
3. The Comptroller of Customs and Inland Revenue may at his discretion require an exporter to furnish security in the shape of a deposit or bond to the amount of double the value of the goods pending the production by such exporter of a certificate from the Customs Authorities at the port or place of ultimate destination proving that the goods so exported have arrived at such destination.
