**THE EMERGENCY POWERS (CYPRUS DEFENCE)  
REGULATIONS, 1939.**

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 43.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 43 of the Emergency Powers (Cyprus Defence) Regulations, 1939, I hereby order as follows:—

1. This Order may be cited as the Defence (Sale of Fertilizers Restriction) Order, 1939.

2. For the purposes of the Order—

“dealer in fertilizers” means any person who has in his possession or under his control—

(a) any fertilizers for the purposes of sale by retail or by wholesale, and

(b) any fertilizers exceeding 25 bags in number.

“fertilizer” means any substance which has been subjected to any artificial process and which is or has been imported into the Colony of Cyprus for use as a fertilizer of the soil, whether mixed with any other substance or not.

3. Within two days of the date of the publication of this Order in the *Gazette*, every dealer in fertilizers shall complete and deliver to me in duplicate at Nicosia a declaration in the form set forth in the Schedule hereto, in respect of all fertilizers which he holds in stock or in his possession or under his control.

4. Every person importing any fertilizers after the expiration of the period specified in clause 3 of this Order, shall, within twenty-four hours of taking delivery thereof, notify me of the arrival and amount and type of each consignment of fertilizers received by him and of the place or places where such fertilizers are stored.

5. The Commissioner of each District shall, if so required by me, appoint Inspectors to enquire into the quantities of fertilizers which are held in stock or are in the possession or control of any person or generally of all persons residing in any town or village within his District.

6. On and from the date of the publication of this Order in the *Gazette*, no dealer in fertilizers shall sell any fertilizer to any person except under and in virtue of a special permit—

(a) issued under my hand ; and

(b) delivered either to the dealer in fertilizers or to the prospective purchaser of the fertilizer.

7. Every special permit issued under the provisions of clause 6 of this Order may contain such terms and conditions (including the price at which the fertilizer is to be sold or purchased) as may be specified therein.

8. Any dealer in fertilizers who—

(a) acts in contravention of the provisions of this Order or of any of the terms and conditions specified in a special permit issued under this Order ; or

(b) makes a false declaration under clause 3 of this Order,

shall be liable to the penalties prescribed in Regulation 63 (1) of the Emergency Powers (Cyprus Defence) Regulations, 1939.
