15. Costs and expenses incurred by the Custodian in respect of enemy Costs and property to which this Order applies shall be a first charge on the enemy expenses property in respect of which such costs and expenses were incurred, and incurred by the Custodian shall reimburse himself of such costs and expenses out of such enemy property.

16. All registers, books and accounts kept by the Custodian shall be Auditing of Custodian's subject to audit by the Auditor at such times as the Governor may direct. accounts.

17.—(1) Where in respect of any enemy subject a detention order Vesting of has been made under the provisions of regulation 62 (3) of the Emergency Powers (Cyprus Defence) Regulations 1020 and such detection of enemy Powers (Cyprus Defence) Regulations, 1939, and such detention order subjects in has been confirmed by the Governor under the provisions of regulation Custodian. 62 (5) of the said Regulations, any property for the time being belonging to or held or managed on behalf of such enemy subject shall vest in the Custodian and the provisions of this Order shall, so far as the same may be applicable, apply thereto.

(2) Upon the confirmation by the Governor of an order of detention under regulation 62 (5) of the said Regulations the authority by whom the order was made shall notify the Custodian of the confirmation thereof and shall furnish the Custodian with such particulars of any property of the enemy subject to whom the order relates as the Custodian may

18. Any person who acts in contravention of, or fails to comply with, Penalties any of the provisions of this Order shall be liable to the penalties and prescribed in sub-sections (5) and (6) of section 9 of the Trading with the Enemy Law, 1939, and proceedings therefor may be taken against such 16 of 1939 person under the provisions of the said sub-sections or of section 11 of the said Law, as the case may be.

## THE EMERGENCY POWERS (CYPRUS DEFENCE) REGULATIONS, 1939.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 43.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 43 of the Emergency Powers (Cyprus Defence) Regulations, 1939, I hereby order as follows:—

- 1. This Order may be cited as the Defence (Regulation of Sale Prices) (Certain Petroleum Products) Order, 1939, and shall come into operation on and from the date of its publication in the Gazette.
  - 2. No person shall—
  - (a) sell or purchase, or
  - (b) offer for sale or attempt to sell or purchase, or
  - (c) either directly or indirectly make any arrangement for the sale or purchase of,

any petroleum product in any town or village in the Colony at a price in excess of the official prices ruling therefor on the 20th day of August, 1939, plus one piastre per kilo.

- 3. For the purposes of this Order, the term "petroleum product" means any inflammable liquid or substance derived from petroleum other than the products known as motor spirit, petrol, kerosene or fuel oil.
- 4. Any person who acts in contravention of the provisions of clause 2 of this Order shall be liable to the penalties prescribed in Regulation 63 (1) of the Emergency Powers (Cyprus Defence) Regulations, 1939.

THE EMERGENCY POWERS (CYPRUS DEFENCE)
REGULATIONS, 1939.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 52.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 52 of the Emergency Powers (Cyprus Defence) Regulations, 1939, I hereby order as follows:—

1. This Order may be cited as the Defence (Lighting Restrictions) Order, 1939, and shall come into operation on and from the date of its publication in the *Gazette*.

2. All lights, whether public or private, in any town, village or place in the Colony which would be visible from the sea, shall be extinguished or adequately obscured in such manner as the Commissioner of the District may from time to time direct:

Provided that nothing in this Order contained shall apply to lights carried on motor cars or other vehicles travelling during the night, as long as such lights are not of greater brightness than is necessary for the public safety.

3. Any person acting in contravention of this Order or of any direction given by the Commissioner of the District as in clause 2 hereof provided shall be liable to the penalties prescribed in Regulation 63 (1) of the Emergency Powers (Cyprus Defence) Regulations, 1939.
