**No. 291. THE BURIALS LAWS, 1896 AND 1937.**

ORDER MADE UNDER SECTION 14.

Whereas in pursuance of Notification No. 216 published in Supplement No. 3 to *Gazette* No. 2621 of the 3rd December, 1937, a fit and proper site has been registered in the books of the Land Registry Office as a burial-ground for the burial of the dead by the Orthodox-Christian Community of the village of Galata, in the District of Nicosia :

Now, therefore, in exercise of the powers vested in him by section 14 of the Burials Laws, 1896 and 1937, His Excellency the Governor has been pleased to order and hereby orders that, from and after the 22nd day of October, 1939, no burial shall take place in the burial-ground in lieu whereof the new burial-ground above referred to has been provided.

**No. 292. The Village Authorities Laws, 1931 to (No. 2) 1937.**

SPECIAL AUTHORIZATION UNDER SECTION 13A (1).

By virtue of the powers vested in me by section 13A (1) of the Village Authorities Laws, 1931 to (No. 2) 1937, I hereby authorize the Mukhtars the names whereof are mentioned in the Schedule hereto to issue, on the application in writing of a Police Officer of any rank not lower than that of Corporal or of any Police Officer in charge of a Police Station, warrants for the purposes of the said section of the said Laws, in addition to the Mukhtars already authorized to issue such warrants.
