**THE CYPRUS EXPORTATION OF ARMS ORDER AND LAW,  
1903 AND 1934.**

PROCLAMATION MADE BY THE GOVERNOR.

W. D. BATTERSHILL,  
*Governor.*

In exercise of the powers vested in me by the Cyprus Exportation of Arms Order and Law, 1903 and 1934, I, William Denis Battershill, Companion of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Colony of Cyprus, do hereby proclaim and order that the Proclamation, dated the 5th day of September, 1936, (relating to the prohibition of exportation or re-exportation to Spain of arms, ammunition, aircraft, military and naval stores), and published under Notification No. 867 in the *Gazette* of the 7th September, 1936, shall be and is hereby revoked, without prejudice to anything done or left undone thereunder.

**THE MISSIONARY EDUCATIONAL AND MEDICAL (ALIEN  
REGULATION) LAWS, 1922 AND 1933.**

ORDER IN COUNCIL No. 1884

MADE UNDER SECTION 7.

Whereas in pursuance of the provisions of the Missionary Educational and Medical (Alien Regulation) Laws, 1922 and 1933, the persons whose names appear in the Schedule hereto have applied for permits under the provisions of the said Laws ;

And whereas the said persons have severally given an undertaking in writing to pay due obedience and respect to the Government of Cyprus, and while carefully abstaining from participation in political affairs, that they

desire and purpose *ex animo* to work in friendly co-operation with the said Government in all matters in which their influence might properly be exerted; and, in particular, they have undertaken that if engaged in educational work, their influence will be exerted to promote loyalty to the Government of Cyprus in the minds of their pupils, and to make them good citizens of the British Empire.

Now, therefore, in exercise of the powers vested in him by the said Laws, and otherwise, and with the advice of the Executive Council, His Excellency the Governor is pleased to grant to the persons whose names appear in the Schedule hereto a permit respectively to commence or to carry on the work set down after their respective names.
