1. This Order may be cited as the Trades and Industries (Regulated Trades) Amendment Order, 1939, and shall be read as one with the

Trades and Industries (Regulated Trades) Order, 1937, (hereinafter called "the Principal Order"), and the Principal Order and this Order may together be cited as the Trade and Industries (Regulated Trades) Orders, 1937 and 1939.

2. The Schedule to the Principal Order is hereby amended by the insertion of the following items at the end thereof :—

" 33. Shoemakers establishments.

34. Shirtmakers establishments in which more than five persons, excluding the owner or the person in charge thereof, are employed."

**THE EMERGENCY POWERS (CYPRUS DEFENCE)
(FINANCE) REGULATIONS, 1939.**

ORDER MADE BY THE GOVERNOR UNDER REGULATION 4 (1).

In exercise of the powers vested in him by regulation 4 (1) of the Emergency Powers (Cyprus Defence) (Finance) Regulations, 1939, His Excellency the Governor has been pleased to order and it is hereby ordered as follows :—

1. This Order may be cited as the Emergency Powers (Restriction on Export of Currency, Gold and Securities) (Exemption) Order, 1939.

2. Transactions under regulation 4 (1) (b) of the Emergency Powers (Cyprus Defence) (Finance) Regulations, 1939, with any part of the British Empire except Canada, Newfoundland and Hong Kong and with Egypt and Iraq shall be and are hereby exempted from the provisions of regulation 4 of the said regulations.

3. This Order shall be deemed to have commenced and come into operation on the first day of November, 1939, and the Defence (Restriction on Export of Currency, Gold and Securities) (Exemption) Order, 1939, shall be deemed to have been repealed as from that date, without prejudice to anything done or left undone thereunder.
