In exercise of the powers vested in him by regulation 4 (1) of the Emergency Powers (Cyprus Defence) (Finance) Regulations, 1939, His Excellency the Governor has been pleased to order and it is hereby ordered as follows:—

1. This Order may be cited as the Emergency Powers (Restriction

on Export of Currency, Gold and Securities) (Exemption) Order, 1939.
2. Transactions under regulation 4 (1) (b) of the Emergency Powers (Cyprus Defence) (Finance) Regulations, 1939, with any part of the British Empire except Canada, Newfoundland and Hong Kong and with Egypt and Iraq shall be and are hereby exempted from the provisions of regulation 4 of the said regulations.

3. This Order shall be deemed to have commenced and come into operation on the first day of November, 1939, and the Defence (Restriction on Export of Currency, Gold and Securities) (Exemption) Order, 1939, shall be deemed to have been repealed as from that date, without prejudice to anything done or left undone thereunder.

In exercise of the powers vested in him by section 12 of the Construction of Buildings, Streets and Wells on Arazi Mirié Laws, 1927 to 1938, His Excellency the Governor, with the advice of the Executive Council, is pleased to make and hereby makes the following Regulations:—

1. These Regulations may be cited as the Construction of Buildings, Streets and Wells on Arazi Mirié (Amendment) Regulations, 1939, and shall be read as one with the Construction of Buildings, Streets and Wells on Arazi Mirié Regulations, 1938, (hereinafter called "the Principal Gazette: Regulations "), and the Principal Regulations and these Regulations may together be cited as the Construction of Buildings, Streets and Wells on Arazi Mirié Regulations, 1938 and 1939.

2. Paragraph (a) of regulation 11 of the Principal Regulations is hereby revoked and the following paragraph is substituted therefor:-

(a) (i) The sum of the areas of any plot which may be occupied by existing buildings and any new buildings or additions and extensions to existing buildings which it is intended to construct,
