THE EMERGENCY POWERS (CYPRUS DEFENCE) REGULATIONS, 1939.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 43.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 43 of the Emergency Powers (Cyprus Defence) Regulations, 1939, I hereby order as follows:

1. This Order may be cited as the Defence (Regulation of Sale Prices) (Imported Articles) General (Amendment) Order, 1939, and shall be read as one with the Defence (Regulation of Sale Prices) (Imported Articles) General Order, 1939, (hereinafter called "the Principal Order"), and the Gazette: Principal Order and this Order may together be cited as the Defence (Regulation of Sale Prices) (Imported Articles) General Orders, 1939.

- 2. The following clauses shall be inserted in the Principal Order immediately after clause 11 thereof:
 - "11A. Notwithstanding anything in clause 4 of this Order contained, any person may-
 - (a) sell or purchase, or
 - (b) offer for sale or attempt to sell or purchase, or
 - (c) either directly or indirectly make any arrangement for the sale or purchase of,

any of the imported articles specified in column 1 of the Schedule hereto at a price which would give the vendor, where such vendor is the person who has imported such article into the Colony, a profit not in excess of the percentage of profit shown in column 2 of the said Schedule opposite the name of each such article, such percentage of profit to be calculated on the total value of such article for the time being.

- 11B. Notwithstanding anything in clause 5 of this Order contained, any person may-
 - (a) sell or purchase, or
 - (b) offer for sale or attempt to sell or purchase, or
 - (c) either directly or indirectly make any arrangement for the sale or purchase of,

any of the imported articles specified in column 1 of the Schedule hereto at a price which would give the vendor, where such vendor is a person who has purchased such article within the Colony for the purpose of resale, a profit not in excess of the percentage of profit shown in column 3 of the said Schedule opposite the name of each such article, such percentage of profit to be calculated on the total value of such article for the time being."

- 3. Clause 12 of the Principal Order is hereby repealed and the following clause is substituted therefor:-
 - "12. Nothing in this Order shall be deemed to apply to, or affect, any imported article in respect of the sale price of which a specific Order has been made by me under Regulation 43 of the Emergency Powers (Cyprus Defence) Regulations, 1939, and is subsisting for the time being."
- 4. Clause 13(1)(a) of the Principal Order is hereby amended by the i nsertion of the words "or 11A or 11B" before the words "of this Order".

5. The following Schedule shall be inserted in the Principal Order at the end thereof :—

Rules.

- 1. These Rules may be cited as the Irrigation Division of Nata (Amendment) Rules, 1939, and shall be read as one with the Irrigation Division of Nata Rules, 1937, (hereinafter called "the Principal Rules"), and the Principal Rules and these Rules may together be cited as the Irrigation Division of Nata Rules, 1937 and 1939.
- 2. Rule 5 of the Principal Rules is hereby amended by the substitution of the words "four shillings" by the words "six shillings".
 - 3. Rule 17 of the Principal Rules is hereby deleted.
