(c) either directly or indirectly make any arrangement for the sale or purchase by retail of,

any locally-made macaroni of the kind described in column (1) of the Schedule hereto, in any of the towns or villages specified in column (2) of the said Schedule, at a price in excess of the retail price specified in column (3) of the said Schedule opposite the kind of such locally-made macaroni."

3. Clause 3 of the Principal Order is hereby repealed and the following clause is substituted therefor :---

"3. No person shall—

(a) sell or purchase by wholesale, or

(b) offer for sale or attempt to sell or purchase by wholesale, or

(c) either directly or indirectly make any arrangement for the sale or purchase by wholesale of,any locally-made macaroni of the kind described in column (1) of the
