THE EMERGENCY POWERS (CYPRUS DEFENCE) REGULATIONS, 1939.

Order made by the Competent Authority under Regulation 43.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 43 of the Emergency Powers (Cyprus Defence) Regulations, 1939, I hereby order as follows :—

1. This Order may be cited as the Defence (Sale of Sulphur Olive Oil Restriction) Order, 1939.

2. Within three days of the date of the publication of this Order in the *Gazette*, every person who has in his possession or under his control any sulphur olive oil shall complete and deliver to me at Nicosia a declaration in the form set forth in the Schedule hereto, in respect of all such sulphur olive oil.

3. No person shall—

(a) manufacture, or

(b) sell or purchase, or

(c) offer for sale or attempt to sell or purchase, or

(d) either directly or indirectly make any arrangement for the sale or purchase of, or

(e) otherwise dispose of,

any sulphur olive oil containing more than five per centum impurities as determined by the petrol ether test.

4.--(1) No person shall--

(a) sell or purchase, or

- (b) offer for sale or attempt to sell or purchase, or
- (c) either directly or indirectly make any arrangement for the sale or purchase of, or
- (d) otherwise dispose of,

any sulphur olive oil save in accordance with the following provisions, that is to say :---

A. As regards the seller,

- (i) he shall be the holder of a permit issued under my hand authorizing him to sell sulphur olive oil;
- (ii) he shall not sell any sulphur olive oil to any person unless such person is the holder of a permit under my hand authorizing him to purchase sulphur olive oil and such person hands such permit to the seller, before the sale.

B. As regards the purchaser,

- (i) he shall be the holder of a permit under my hand authorizing him to purchase such quantity of sulphur olive oil as may be specified in such permit;
- (ii) he shall hand to the seller his permit to purchase, before the sale.

(2) The provisions of this clause shall apply *mutatis mutandis* to any person who disposes of any sulphur olive oil otherwise than by sale.

5. A permit issued under the provisions of clause 4 of this Order may contain such terms and conditions (including the price at which the sulphur olive oil is to be sold or purchased) as may be specified therein.

6. Where any person who holds any stock of sulphur olive oil on being presented with a permit issued to a prospective purchaser of sulphur olive oil under the provisions of clause 4 of this Order and on demand being made to him by such purchaser, refuses to sell to such purchaser any sulphur olive oil as may be specified in the permit presented by such purchaser, and such refusal is in my opinion unreasonable, he shall, at my request, deliver such sulphur olive oil to me to be disposed of as I may in that behalf direct.

7. The Commissioner of each District shall, if so required by me, appoint Inspectors to enquire into the stocks of sulphur olive oil which are in the possession or under the control of any person or generally of all persons residing within his District and such Inspectors may enter upon any premises for the purpose of carrying out any inspection or search reasonably required in order to obtain the necessary information concerning the amount or condition of the stock of any such sulphur olive oil.

8. Any person who-

- (a) acts in contravention of the provisions of this Order or of any of the terms and conditions specified in any permit issued under clause 4 of this Order, or
- (b) makes a false declaration under clause 2 of this Order,

shall be liable to the penalties prescribed in Regulation 63 (1) of the Emergency Powers (Cyprus Defence) Regulations, 1939.
