THE EMERGENCY POWERS (CYPRUS DEFENCE)  
REGULATIONS, 1939.

## ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 9.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 9 of the Emergency Powers (Cyprus Defence) Regulations, 1939, I hereby order as follows :—

1. This Order may be cited as the Defence (Closing Time of Places of Public Resort and Entertainments) (Famagusta-Varosha) Order, 1939, and shall come into operation on and from the date of its publication in the *Gazette*.

2. This Order shall apply and be in operation in the Municipal area of Famagusta-Varosha.

3. All coffee-shops, clubs, restaurants, theatres, cinematograph theatres, confectioners' shops, cabarets and any other place or premises of public resort whatsoever shall be closed and remain closed except between the hours of 6 a.m. and 12 midnight from the 1st June to the 30th September and between the hours of 6 a.m. and 11 p.m. from the 1st October to the 31st May in every year during the continuance of this Order :

Provided that any of the places or premises aforementioned may, upon the manager or person in charge thereof obtaining a permit under my hand, remain open until such time as may be specified in such permit :

Provided also that, in order to meet the needs of early workers, coffee-shops not being premises licensed for the sale of intoxicating liquors, may be opened at 4 a.m. from the 1st June to the 30th September and at 5 a.m. from the 1st October to the 31st May in every year during the continuance of this Order.

4. Any person acting in contravention of any of the provisions of this Order shall be liable to the penalties prescribed in Regulation 63 (1) of the Emergency Powers (Cyprus Defence) Regulations, 1939.

5. The Defence (Control of Places of Public Resort and Entertainments) (Famagusta-Varosha) Order, 1939, is hereby revoked.
