LIMITS OF THE MUNICIPAL CORPORATION OF KYRENIA.

NOTICE UNDER SECTION 6.

In exercise of the powers vested in him by section 6 of the Municipal Corporations Laws, 1930 to 1938, His Excellency the Governor has been pleased to declare and hereby declares that as from the 1st day of January, 1940, the limits of the Municipal Corporation of Kyrenia shall be as set forth in the Schedule hereto and that the limits of the Municipal Corporation of Kyrenia as set forth in the Order in Council No. 993 dated the 4th March, 1924, and published under Notification No. 137 in the Gazette of the 14th March, 1924, shall be cancelled.

SCHEDULE.

The boundary commences at the north-western corner of plot No. 15/3 of the Government Survey Plan No. XII/12, on the seashore, and proceeds eastwards along the seashore to the mouth of the river "Yiatsime Deresi," Government Survey Plan No. XII/21; thence southwards along the left bank of the said river to the most southern point of plot No. 142/1 of the said plan, on the main road from Ayios Epiktitos to Kyrenia; thence westwards along the said main road to the north-eastern corner of plot No. 161 of the said plan; thence eastwards and southwards along the boundaries of, and including, plots Nos. 161, 165, 166, 170, 171, 172, 238, 239, 240, 243, 241 and 230 of the said plan, plots Nos. 31, 32, 34/1, 33, 34, 35, 36, 28/3, 23 and 22 of the Government Survey Plan No. XII/29 to the most southern point of the last-mentioned plot, on the main road from Nicosia to Kyrenia; thence north-westwards along the said main road to the most eastern point of plot No. 220 of the Government Survey Plan No. XII/21; thence westwards and southwards along the boundaries of, and including, plots Nos. 220, 219, 216, 215, 214, 212 and 211 of the said plan, plot No. 241 of the Government Survey Plan No. XII/20, plot No. 209 of the Government Survey Plan No. XII/21, plots Nos. 240/1, 240, 235, 224, 226, 225, 210, 200 and 198 of the Government Survey Plan No. XII/20 to the south-western corner of the last-mentioned plot, on the stream "Kalava Deresi"; thence northwards along the said stream to the lower road from Kyrenia to Templos; thence southwestwards along the said road to the south-western corner of plot No. 67 of the said plan, which point is on a track leading to the main road from Lapithos to Kyrenia; thence north-westwards and north-eastwards along the said track to the said main road; thence eastwards along the said main road to the south-western corner of plot No. 26/2 of the said plan, at which point the road to Glykiotissa Church leaves the said main road; thence northwards along the said road to Glykiotissa Church to the north-western corner of plot No. 18/2 of the Government Survey Plan No. XII/12; thence northwards along the western boundary of plot No. 15/3 of the said plan to the point of commencement. The Municipal Area of Kyrenia as described above is more particularly shewn bordered purple on Serial Plan No. 1157 filed in the office of the Director of Land Registration and Surveys.
