THE CUSTOMS LAWS, 1936 TO (No. 2) 1938.

ORDER IN COUNCIL No. 1852

MADE UNDER SECTION 52.

In exercise of the powers vested in him by section 52 of the Customs Laws, 1936 to (No. 2) 1938, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order and it is hereby ordered as follows :—

1. This Order may be cited as the Import Duty (Mining Safety Boots, Shoes and Goggles) Exemption Order, 1939.
2. Any boots or shoes specified in item (1) or (2) in the Schedule to this Order—
 - (a) imported into the Colony by or on behalf of any Mining Company carrying on mining operations in the Colony for the time being ; and
 - (b) proved to the satisfaction of the Comptroller to be—
 - (i) solely required for use in the mine of such Mining Company, and
 - (ii) in such numbers as are required for such use, and
 - (iii) of a pattern previously approved by the Comptroller,shall be admitted into the Colony free from all import duties.
3. Any goggles specified in item (3) in the Schedule to this Order—
 - (a) imported into the Colony by or on behalf of any Mining Company carrying on mining operations in the Colony for the time being ; and

- (b) proved to the satisfaction of the Comptroller to be—
 (i) solely required for use in the mine of such Mining Company,
 and
 (ii) in such numbers as are required for such use,
 shall be admitted into the Colony free from all import duties.
