

**No. 61.****THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1938.****LIMITS OF THE MUNICIPAL CORPORATION OF LEFKONIKO.***Notice under Section 6.*

In exercise of the powers vested in him by section 6 of the Municipal Corporations Laws, 1930 to 1938, His Excellency the Governor has been pleased to declare and hereby declares that upon the proclamation of the village of Lefkoniko, in the Famagusta District, as a Municipal Corporation on the 1st day of April, 1939, the municipal limits of such Corporation shall be as set forth in the Schedule hereto.

**SCHEDULE.***Limits of the Municipal Corporation of Lefkoniko.*

The boundary commences at the south-western corner of plot No. 207 of the Government Survey plan No. XIV/60, locality "Karioluckos," which point is on the northern side of the main road from Nicosia to Famagusta, and proceeds northwards along the boundaries of, and including, plots Nos. 207, 194, 192, 185, 189, 186, 187, 46, 45, 44, 43, 42, 41, 39, 38, 37, locality "Melisha," plots Nos. 35, 33, 31, 30, 26, 28, 27 and 1 of the said plan and plot No. 680 of the Government Survey plan No. XIV/52, locality "Trakhonas," to the most northern point of plot No. 680 of the said plan on a road from the village of Gouphe to Lefkoniko; thence south-eastwards in a straight line (across this road) to the most southern point of plot No. 681 of the said plan; thence north-eastwards along the boundaries of, and including, plots Nos. 678, 677, 676, 657, 656, 655, 652 and 651 of the said plan to the most northern point of plot No. 651 of the said plan on a track leading to Lefkoniko; thence southwards along this track to the most southern point of plot No. 648 of the said plan; thence north-eastwards along the northern boundary of plot No. 649 of the said plan to a road leading from the village of Gouphe to Lefkoniko; thence south-eastwards along the western side of this road to the north-western corner of plot No. 465 of the Government Survey plan No. XIV/60; thence north-eastwards along the boundaries of, and including, plots Nos. 465 (crossing the road from the village of Artemi to Lefkoniko), 562 and 563 of the said plan to the most southern point of plot No. 566 of the said plan, which point is on the right bank of the river "Sejias Potamos"; thence north-eastwards along the right bank of this river to the most northern point of plot No. 567 of the said plan; thence eastwards along the boundaries of, and including, plots Nos. 567 and 568 of the said plan to the most northern point of plot No. 568 of the said plan, which point is on the western side of a road from Lefkoniko to the village of Akanthou; thence eastwards (across this road) to the north-western corner of plot No. 572 of the said plan; thence eastwards along the boundaries of, and including, plot No. 572 of the said plan, plot No. 522 of the Government Survey plan, No. XIV/52, plots Nos. 584 and 585 of the Government Survey plan No. XIV/60, plot No. 432 of the Government Survey plan No. XIV/52 to the north-eastern corner of plot No. 432 of the said plan, which point is on the main road to Akanthou; thence south-eastwards (across this road) to the north-western corner of plot No. 431 of the said plan; thence eastwards along the boundaries of, and including, plot No. 431 of the

said plan, plot No. 587 of the Government Survey plan XIV/60, plots Nos. 429, 428, 427 and 426 of the Government Survey plan No. XIV/52 to the most eastern point of plot No. 426 of the said plan, on the right bank of the river "Kryos Potamos"; thence (crossing this river) to the most northern point of plot No. 413 of the said plan; thence south-eastwards along the northern boundary of this plot to a road from Lefkoniko to the village of Platani; thence north-eastwards along the eastern side of this road to the north-western corner of plot No. 412 of the said plan; thence eastwards along the boundaries of, and including, plots Nos. 412 and 726 of the said plan, plot No. 649 of the Government Survey plan No. XIV/60 to the most eastern point of this plot, which point is on the road from Lefkoniko to the village of Platani; thence south-westwards along the western side of this road to a point due west of the north-western corner of plot No. 653 of the said plan; thence eastwards (across this road) along the boundaries of, and including, plots Nos. 653 and 652 of the said plan, plots Nos. 2, 8, 7, 10 and 11 of the Government Survey plan No. XIV/61 to the most eastern point of plot No. 11 of the said plan, locality "Mallies," on a footpath; thence south-eastwards along this footpath and including plots Nos. 11, 54, 53 and 52 (crossing a road from the village of Platani to Lefkoniko), plots Nos. 65, 66, 78, locality "Kotchinoyes," plots Nos. 121 and 122 of the said plan to the south-eastern corner of plot No. 122 on the northern side of the main road from Nicosia to Famagusta at the most western point of plot No. 115 of the said plan; thence south-eastwards across this road and southwards along the boundaries of, and including plots Nos. 134, 136, 181, 179, 178, 176 and 175 of the said plan to the south-eastern corner of plot No. 175 of the said plan, which point is on a road; thence westwards along this road to the north-eastern corner of plot No. 201 of the said plan; thence southwards along the boundaries of, and including plots Nos. 201, 200, 250 (crossing a road), plot No. 253 of the said plan, plot No. 918 of the Government Survey plan No. XIV/60, plot No. 260 of the Government Survey plan No. XIV/61, plot No. 921 of the Government Survey plan No. XIV/60 (crossing the road leading from Lefkoniko to the village of Milea), plots Nos. 923, 922, 892, 889, 886 of the said plan to the most southern point of plot No. 886 of the said plan, which point is on the left bank of a tributary of the river "Kryos Potamos"; thence north-westwards along this bank of this tributary to a point due east of the most northern point of plot No. 670 of the Government Survey plan No. XXIII/4; thence westwards (across this tributary) to the most northern point of the said plot No. 670; thence south-westwards along the boundaries of, and including, plots Nos. 867 and 868 of the Government Survey plan No. XIV/60 to the most western point of plot No. 868 of the said plan, which point is on the left bank of the river "Kryos Potamos"; thence south-westwards across this river and along its right bank to the most southern point of plot No. 855 of the said plan; thence northwards and westwards along the boundaries of, and including, plots Nos. 855, 857, 856, 852, 851, 835 (crossing the road from Lefkoniko to the village of Pyrga), plots Nos. 836, 847, 846 and 845 of the said plan, plot No. 542 of the Government Survey plan No. XXIII/4, plot No. 341 of the Government Survey plan No. XIV/60, plot No. 526 of the Government Survey plan No. XXIII/4, plots Nos. 339 and 337 of the Government Survey plan No. XIV/60 to the south-western corner of plot No. 337 of the said plan, which point is on a road leading to the village of Pyrga; thence northwards along the eastern side of this road to the cross-roads at the north-western corner of plot No. 337 of the said plan; thence south-westwards along the northern side of the road forming the

southern sides of plots Nos. 335, 334, 333, 331, 330 and 242 of the said plan to the most southern point of plot No. 242 of the said plan ; thence north-westwards along the boundaries of, and including, plots Nos. 242, 244, 240, 239, 234, 238, 236, 237, 221, 222, 224 (crossing a road), plots Nos. 215, 214, 213, 211 and 208 of the said plan to the north-western corner of plot No. 208 of the said plan, which point is on the southern side of the main road from Nicosia to Famagusta ; thence northwards in a straight line to the point of commencement, all which said boundary is delineated in red on the Government Survey plan Serial No. 1161.

**No. 62. THE BURIALS LAWS, 1896 AND 1937.**

ORDER MADE UNDER SECTION 1.

Whereas the burial-ground situated in the village of Kalokhorio (Dagh), District of Nicosia, now in use by the Orthodox-Christian Community for the burial of the dead, is dangerous to the health of the said village :

Now, therefore, in exercise of the powers vested in him by section 1 of the Burials Laws, 1896 and 1937, His Excellency the Governor has been pleased to order and hereby orders that a new burial-ground, in substitution for the burial-ground now in use as aforesaid, shall be provided under the provisions of the said Laws.
