THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1938.

ORDER IN COUNCIL No. 1855

In exercise of the powers vested in him by section 10 of the Municipal Corporations Laws, 1930 to 1938, His Excellency the Governor, with the advice of the Executive Council, is pleased to direct and hereby directs that, upon the proclamation of the village of Lefkoniko, in the Famagusta District, as a Municipal Corporation on the 1st day of April, 1939, the number of Councillors of such Corporation shall be seven as follows:—

Six Christian Councillors.
One Moslem Councillor.

No. 68. THE IMMIGRATION LAWS, 1936 TO 1938.

ORDER MADE UNDER SECTION 8 (3).

In exercise of the powers vested in him by section 8 (3) of the Immigration Laws, 1936 to 1938, His Excellency the Governor is pleased to order and it is hereby ordered that, as from the 1st day of April, 1939, British Consular visas may be dispensed with in the following cases, that is to say in the case of—

- (a) nationals of Denmark, Egypt, France, Iceland, Iraq, the Principality of Liechtenstein, the Netherlands, Norway, Palestine, Spain, Sweden and Switzerland;
- (b) Sudanese passports;
- (c) Italian tourists travelling to Cyprus;

(d) any alien who permanently resides in the Colony and who has obtained from the Principal Immigration Officer an endorsement on his passport under Regulation 4 of the Immigration Regulations, 1936, verifying the fact of his permanent residence in the Colony.

2. The Order published in the *Gazette* Supplement No. 3 of the 10th June, 1938, under Notification No. 101, is revoked with effect from the 1st day of April, 1939.

No. 69. The Criminal Evidence and Procedure Laws, 1929 to 1934.
