

No. 7. THE BURIALS LAWS, 1896 AND 1937.

ORDER MADE UNDER SECTION 14.

Whereas in pursuance of Notification No. 418 published in the *Gazette* of the 5th April, 1935, a fit and proper site has been registered in the books of the Land Registry Office as a burial-ground for the burial of the dead by the Orthodox-Christian Community of the village of Pharmakas, in the District of Nicosia :

Now, therefore, in exercise of the powers vested in him by section 14 of the Burials Laws, 1896 and 1937, His Excellency the Governor has been pleased to order and hereby orders that, from and after the 15th day of January, 1939, no burial shall take place in the burial-ground in lieu whereof the new burial-ground above referred to has been provided.

THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

ORDER MADE UNDER SECTION 13.

Whereas at a meeting duly convened and held at the village of Perivolia, in the District of Larnaca, on the 7th day of August, 1938, it was determined by the requisite majority of the voters present thereat that a certain area should be reserved as the Tree Planting Area of the village of Perivolia.

And whereas at the said meeting the boundaries of the said area have been fixed and described :

And whereas the Mukhtar of the village of Perivolia has forwarded to the Commissioner of the District of Larnaca a report, signed and sealed by him, containing a description with boundaries of the said area and stating that the said area fulfils the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed :

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Colonial Secretary for the consideration of the Governor :

And whereas the Governor considers it expedient, having regard to all the circumstances, that the area in the said report described should be reserved as the Tree Planting Area of the village of Perivolia :

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows :—

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Perivolia in the District of Larnaca.

SCHEDULE.

The area lying within the following boundaries, that is to say :—

The boundary commences at the most northern point of plot No. 86 shewn on the Government Survey plan No. L. 39, locality "Kokkines," on the road from the village of Perivolia to the village of Meneou, and proceeds south-eastwards and north-eastwards along the boundaries of, and including, plots Nos. 86, 88, 81, 84, 89, 91, 93, 108, 109, 110, 113 and 111 of the said plan, plot No. 8 of the Government Survey plan No. L. 40 to the most eastern point of plot No. 8 of the said plan, locality "Aspradhia," on a footpath; thence south-westwards along the said footpath to the most southern point of plot No. 30, of the Government Survey plan No. L. 47; thence north-westwards along the boundaries of, and including, plots Nos. 30 and 49 of the said plan to the most northern point of plot No. 48 of the said plan, on a footpath, locality "Khiro-Lakki"; thence north-westwards along the said footpath to the most southern point of plot No. 139 of the Government Survey Plan No. L. 39, at which point the said footpath is crossed by a stream; thence north-westwards along the said stream to the most northern point of plot No. 120 of the said plan; thence south-westwards and north-westwards along the boundaries of, and including, plots Nos. 121, 103 and 101 of the said plan to the most western point of plot No. 101 of the said plan, on the road leading from the village of Perivolia to the village of Meneou; thence north-eastwards along the said road to the point of commencement, all which said boundary includes 1,043 donums, be the same more or less, and is shewn edged red on the plan filed in D.L.R.S. M.P. 634/38.

IRRIGATION DIVISION OF EXOMETOKHI.

Rules.

1. These Rules may be cited as the Irrigation Division of Exometokhi Rules, 1939.

2. In these Rules, unless the context otherwise requires :—

"Commissioner" means the Commissioner of the District of Nicosia;

"Committee" means the Committee of the Irrigation Division;

"Irrigation Division" means the Irrigation Division of Exometokhi;

"Law" means the Irrigation Divisions (Villages) Law, 1938;
