THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

## ORDER MADE UNDER SECTION 13.

# H. R. PALMER, Governor.

Whereas at a meeting duly convened and held at the village of Knodhara, in the District of Famagusta, on the 29th day of July, 1938, it was determined by the requisite majority of the voters present thereat that a certain area should be reserved as the Tree Planting Area of the village of Knodhara.

And whereas at the said meeting the boundaries of the said area have been fixed and described:

And whereas the Mukhtar of the village of Knodhara has forwarded to the Commissioner of the District of Famagusta a report, signed and sealed by him, containing a description with boundaries of the said area and stating that the said area fulfils the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed:

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Colonial Secretary for the consideration of the Governor:

And whereas the Governor has decided to limit the area in the said report described :

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows:—

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Knodhara, in the District of Famagusta.

## SCHEDULE.

The area lying within the following boundaries, that is to say:-The boundary commences at the most western point of plot No. 246 of the Government Survey plan No. XIII/64, locality Injirler," on the left bank of the river "Boghaz," and proceeds eastwards along the boundaries of, and including, plots Nos. 245, 243, 244 and 263 to the north-western corner of plot No. 263, which point is on a footpath; thence eastwards along this footpath to the right bank of the river "Latchi"; thence south-eastwards along the right bank of this river to the south-eastern corner of plot No. 623 of the Government Survey plan No. XIV/57, which point is on the main road from Nicosia to Lefkoniko; thence south-westwards along the northern side of the said main road to the junction of the boundaries of the villages of Chatos, Knodhara and Marathovouno on the southern boundary of plot No. 118 of the Government Survey plan No. XXII/8, locality "Kizil Boghaz"; thence north-eastwards along the boundary of the village of Knodhara, to the point of commencement, all which said area is 1,841 donums or thereabouts, as shewn edged in red on the plan filed in D.L.R.S. M.P. 511/38.
