No. 87. THE PRISON DISCIPLINE LAW, 1879.

REGULATIONS MADE UNDER SECTION 4.

H. R. PALMER,

In exercise of the powers vested in him by section 4 of the Prison Discipline Law, 1879, His Excellency the Governor, with the advice of the Executive Council, is pleased to make and hereby makes the following regulations:—

- 1. These Regulations may be cited as the Prison (Amendment) Regulations, 1939, and shall be read as one with the Prison Regulations, 1908 to 1938, (hereinafter called "the Principal Regulations"), and the Principal Regulations and these Regulations may together be cited as the Prison Regulations, 1908 to 1939.
- 2. The following regulation shall be inserted immediately after regulation 147 of the Principal Regulations :—
- "Privilege of smoking and allowance for the cigarettes."
 - 147A.—(1) Convicted prisoners serving sentences of more than six months who have completed six months of their sentence may be credited with an allowance at the rate of one piastre a day for industry and full performance of the task allotted to them for the day accompanied by good conduct.
 - (2) No payments in cash shall be made to any convicted prisoner until his release from prison.

(3) Convicted prisoners to whom paragraph (1) applies may be allowed to purchase weekly through the Prison Authority appointed for this purpose by the Inspector of Prisons cigarettes not exceeding twenty in number for their own use to the value of fifty per cent, of their weekly earnings, the cost of such cigarettes being debited against the prisoner's earnings.

- (4) Notwithstanding anything contained in regulation 183, convicted prisoners to whom paragraph (1) applies may be permitted to smoke at the morning exercise parade at the commencement of the day, after the midday meal and after the sounding of the cease labour bell, but no smoking shall be permitted during labour hours or at any time in cells or workshops.
- (5) The Inspector of Prisons or the Governor of any Prison shall have power to stop any allowance or supply of cigarettes to any prisoner undergoing punishment for any offence against these regulations, or whose work or conduct is unsatisfactory, for such period as he may consider fit.
- (6) Notwithstanding anything contained in this regulation, any child or young person within the meaning of the Juvenile Offenders Law, 1935, who was sent to the Government Stock Farm at Athalassa by any court under the provisions of the said Law prior to the 1st day of January, 1939, and any juvenile adult prisoner being over sixteen and under twenty-one years of age who was detailed for labour at the said Stock Farm prior to the said date may continue to be credited with an allowance at the rate of two piastres per day until such child, young person or juvenile adult prisoner as aforesaid is released or returned to the Central Prison as the case may be."
- 3. These regulations shall be deemed to have commenced and come into operation on the 1st day of January, 1939.
