THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1938.

ORDER IN COUNCIL No. 1859

MADE UNDER SECTION 116 (a) (i).

Authority to the Council of the Municipal Corporation of Limassol to contract a loan.

In exercise of the powers vested in him by section 116 (a) (i) of the Municipal Corporations Laws, 1930 to 1938, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order and it is hereby ordered as follows :—

1. That the Mayor, Deputy Mayor, Councillors and Townsmen of the Municipal Corporation of Limassol (hereinafter referred to as " the Municipal Corporation "), shall be at liberty to borrow from Mrs. Flora Meyer, of London (hereinafter referred to as " the lender "), the sum of five thousand pounds (£5,000) at a rate of interest not exceeding four per centum (4%) per annum subject to the following terms and conditions, that is to say,—

- (a) That the sum borrowed shall be repayable by the Municipal Corporation to the lender in twenty equal annual instalments (comprising sinking fund and interest).
- (b) That the Municipal Corporation shall, in each year and until final repayment of the sum borrowed, insert in the annual estimates as a charge on the revenue the annual instalment repayable in the year to which such estimates relate.
- (c) That the sum borrowed shall be utilized by the Municipal Corporation for the following purposes, that is to say,—
 - (i) for the purchase of a cesspit-emptier a sum of about £650 ;

- (ii) for the replacement by concrete and asbestos-cement pipes of the masonry aqueducts bringing water to the town a sum of about £1,650 ;
- (iii) for the purchase of spare parts and accessories for the new engine installed at the Municipal pumping station a sum of about £180 ;
- (iv) for the acquisition of land situated close to the Municipal drinking water chain of wells a sum of about £220 ;
- (v) for the completion of the Town Hall a sum of about £2,300.

2. That for the purpose of securing the repayment of the said sum of five thousand pounds the Municipal Corporation is hereby authorized, subject to any prior mortgage thereon, to mortgage to the lender all the rates, fees and duties now payable or hereafter to become payable to the Municipal Corporation.

THE IMMIGRATION LAWS, 1936 TO 1938.

REGULATIONS MADE UNDER SECTION 31.

In exercise of the powers vested in him by section 31 of the Immigration Laws, 1936 to 1938, His Excellency the Governor, with the advice of the Executive Council, has been pleased to make and hereby makes the following regulations :—

1. These Regulations may be cited as the Immigration (Amendment) Regulations, 1939, and shall be read as one with the Immigration Regulations, 1936, (hereinafter called "the Principal Regulations"), and the Principal Regulations and these Regulations may together be cited as the Immigration Regulations, 1936 and 1939.

2. Paragraph (2) of Regulation 6 of the Principal Regulations is hereby amended by the addition thereto of the following proviso :—

"Provided that no person shall have an absolute right to the grant of a certificate of immigration."
