NOTIFICATION UNDER SECTION 66.

It is hereby notified that by virtue of the powers vested in the Governor by section 66 of the Customs Laws, 1936 to 1939, and duly deputed to me, I hereby approve the premises described in the third column of the Schedule hereto, belonging to the person whose name is set out in the first column of that Schedule and occupied by the person whose name is set out in the second column of that Schedule, to be a private warehouse for the warehousing of the goods specified in the fourth column of the said Schedule without payment of import duties upon the first entry of such goods therein.

THE EMERGENCY POWERS (CYPRUS DEFENCE)
REGULATIONS, 1939 TO (No. 1) 1939.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 43.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 43 of the Emergency Powers (Cyprus Defence) Regulations, 1939 to (No. 1) 1939, I hereby order as follows:—

1. This Order may be cited as the Defence (Control of Sale Prices of Scheduled Articles) Amendment (No. 4) Order, 1940, and shall be read as one with the Defence (Control of Sale Prices of Scheduled Articles) Orders, 1940 to (No. 3) 1940 (hereinafter called "the Principal Order"), and the Principal Order and this Order may together be cited as the Defence (Control of Sale Prices of Scheduled Articles) Orders, 1940 to (No. 4) 1940.

2. Part 19 of the First Schedule to the Principal Order is hereby repealed and the following Part is substituted therefor:—

"PART 19.—FASOULIA BEANS.

In this Part of this Schedule—
