**THE TRADING WITH THE ENEMY LAW, 1939.**

GENERAL LICENCE MADE UNDER SECTION 3.

In exercise of the powers vested in him by section 3 of the Trading with the Enemy Law, 1939, and of all other powers enabling him in that behalf, His Excellency the Governor has been pleased to authorize and does hereby authorize the Cyprus Chamber of Commerce to pay to or for the benefit of any enemy, on behalf of the owner of any cargo in a ship lying at a port in any country not being enemy territory, for the purpose of obtaining possession of that cargo the following sums, that is to say :—

- (a) where freight has not been paid, an amount not exceeding the full freight which but for the outbreak of war would have been payable on completion of the voyage, and
- (b) in any case, such other amount as the Chamber may deem necessary not exceeding 5 per cent. of the original c.i.f. invoice value of the cargo.

2. The General Licence dated 25th February, 1940, published in Supplement No. 3 of the *Gazette* dated 6th March, 1940, under Notification No. 85 is hereby revoked.
