

NOTIFICATION UNDER SECTION 6.

In exercise of the powers vested in him by section 6 of the Land Acquisition Laws, 1899 to 1936, and with reference to Notification dated the 17th day of June, 1939, and published under No. 142 in Supplement No. 3 to the *Gazette* of the 23rd June, 1939, His Excellency the Governor has been pleased to sanction and hereby sanctions the acquisition, under the provisions of the said Laws, of the immovable properties situated in the village of Morphou, in the District of Nicosia, particulars whereof are specifically set out in the said Schedule, in addition to the acquisition sanctioned by Notification dated the 4th May, 1940, and published under No. 160 in Supplement No 3 to the *Gazette* of the 8th May, 1940.
