

**No. 248. THE DEFENCE REGULATIONS, 1940.**

**ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.**

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 61 of the Defence Regulations, 1940, I hereby order as follows :—

1. This Order may be cited as the Defence (Registration of Retailers of Specified Foodstuffs) Order, 1940.

2. For the purposes of this Order—

“edible oil or fat” means any imported edible oil or fat or vegetable or margarine or lard or butter substitute, commonly used as a foodstuff, but does not include Australian butter;

“registered distributor” means any of the persons specified in the Schedule hereto: Provided that I may, by notice published in the *Gazette*, add to or delete from such Schedule the name of any person;

“registered retailer” means a retailer registered under this Order;

“retailer” means a person who, in the course of his business sells any specified foodstuff to consumers for their household requirements.

“specified foodstuffs” mean sugar and edible oil or fat.

3. Every registered distributor shall, with regard to any matters under this Order, comply with my requirements or directions, from time to time.

4.—(a) From and after the 1st July no person shall carry on the business of a retailer of specified foodstuffs unless he is a registered retailer.

(b) Any person desiring to be registered under this Order as a retailer of specified foodstuffs shall make application therefor to a registered distributor and shall state in such application the quantity of each specified foodstuff under his control or in his possession at the time of his application for registration and thereupon such distributor, unless I shall otherwise direct, shall register such retailer as a retailer of specified foodstuffs and shall provide such retailer with such serial or distinctive number and such books for recording sales as I may, from time to time direct.

5. Except with my consent in writing no retailer shall apply for registration to, nor shall he be registered with, more than one registered distributor, at any one time.

6. Every registered distributor shall, within eleven days of the date of the publication of this Order in the *Gazette*, supply me with a list of the name and address of each retailer registered with him under this Order.

7. From and after the 1st July, 1940, no registered distributor shall sell any specified foodstuff to any retailer other than a retailer registered with him.

8. Any person who acts in contravention of any of the provisions of this Order shall be liable to the penalties prescribed in Regulation 94 of the Defence Regulations, 1940.
