In exercise of the powers vested in him by section 52 of the Customs Laws, 1936 to 1939, His Excellency the Governor, with the advice of the Executive Council, is pleased to order and it is hereby ordered as follows:—

1. This Order may be cited as the Importation of Certain Goods (Prohibition) Amendment (No. 2) Order, 1940, and shall be read as one with the Importation of Certain Goods (Prohibition) Orders, 1939 and 1940, (hereinafter called "the Principal Order"), and the Principal Order and this Order may together be cited as the Importation of Certain Goods (Prohibition) Orders, 1939 to (No. 2) 1940.

2. The proviso to clause 2 of the Principal Order is hereby repealed and the following proviso substituted therefor:—

"Provided that nothing in this Order contained shall apply—

- (a) to any goods proved to the satisfaction of the Comptroller of Customs and Inland Revenue to have been shipped to the Colony prior to the 9th day of December, 1939 ; or
- (b) to any goods which arrive in the Colony prior to the 9th day of February, 1940, and are proved to the satisfaction of the Comptroller of Customs and Inland Revenue to have been ordered prior to the 9th day of December, 1939 ; or
- (c) to any goods consigned through the Postal Service where the value of such goods does not exceed three pounds and such goods are consigned to a private individual for his personal use ; or
- (d) to any *bona fide* baggage (as defined in item 9 of the Second Schedule to the Customs Laws, 1936 to 1939,) being the property of and accompanied by a passenger and proved to the satisfaction of the Comptroller of Customs and Inland Revenue to be for the personal use of such passenger."

No. 28. } THE BURIALS LAWS, 1896 AND 1937.

ORDER MADE UNDER SECTION 1.

Whereas the burial-ground situated in the village of Sykopetra, District of Limassol, now in use by the Orthodox-Christian Community for the burial of the dead, is dangerous to the health of the said village :

Now, therefore, in exercise of the powers vested in him by section 1 of the Burials Laws, 1896 and 1937, His Excellency the Governor has been pleased to order and hereby orders that a new burial-ground, in substitution for the burial-ground now in use as aforesaid, shall be provided under the provisions of the said Laws.
