THE SUMMER AFTERNOON RECESS LAW, 1938.

ORDER IN COUNCIL No. 1961

MADE UNDER SECTION 3.

I, the Governor in Council, in exercise of the powers conferred by section 3 of the Summer Afternoon Recess Law, 1938, do hereby order as follows :---

1. This Order may be cited as the Summer Afternoon Recess (Amendment) Order, 1940, and shall be read as one with the Summer Afternoon Recess Order, 1940, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Summer Afternoon Recess Order, 1940.

2. Clause 2 of the principal Order is hereby amended by the deletion therefrom of the words "between the hours of 12 noon to 2 p.m." (lines 6 and 7) and the substitution therefor of the words "between the hours of 1 p.m. and 3 p.m.".

3. This Order shall come into operation as from the 24th day of July, 1940.

THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

ORDER MADE UNDER SECTION 13.

W. D. BATTERSHILL,

Whereas at a meeting duly convened and held at the village of Anaphotia, in the District of Larnaca, on the 6th day of November, 1939, it was determined by the requisite majority of the voters present thereat that a certain area should be reserved as the Tree Planting Area of the village of Anaphotia.

And whereas at the said meeting the boundaries of the said area have been fixed and described :

And whereas the Mukhtar of the village of Anaphotia has forwarded to the Commissioner of the District of Larnaca a report, signed and sealed by him, containing a description with boundaries of the said area and stating that the said area fulfils the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed :

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Colonial Secretary for the consideration of the Governor:

And whereas the Governor considers it expedient, having regard to all the circumstances, that the area in the said report described should be reserved as the Tree Planting Area of the village of Anaphotia :

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows:—

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Anaphotia, in the District of Larnaca.

SCHEDULE.

The area lying within the following boundaries, that is to say :----

The boundary commences at the north-western corner of plot No. 199 of the Government Survey Plan No. L/41 at the junction of tracks, and proceeds south-eastwards along the track leading to the village of Anaphotia to the most eastern point of plot No. 126 of the Government Survey Plan No. L/42; thence south-eastwards along the boundaries of, and including, plots Nos. 126, 248, 250, 251, 252, 315, 324, 325, 326, 365, 364, 363, 362, 456, 482, 485, 486 and 488 of the said plan to the junction of tracks at the most eastern point of plot No. 488 of the said plan; thence south-eastwards and southwestwards along that track which forms the eastern boundary of plots Nos. 593, 592 and 590 of the said plan to the south-eastern corner of plot No. 378 of the Government Survey Plan No. L/50, on the road from the village of Mazotos to the village of Alaminos; thence westwards along the said village road to the south-western corner of the last mentioned plot, which point is on the boundary of the village of Anaphotia; thence northwards and north-westwards along the said village boundary to the most western point of plot No. 300 of the Government Survey Plan No. L/41, locality "Pallourka," on the track from the village of Alaminos to the village of Menoyia; thence north-eastwards along the said track to the most southern point of plot No. 202 of the said plan, on a footpath; thence northwards along the said footpath to the point of commencement; all which said boundary includes an area of 2,228 donums or thereabouts as shewn edged in red on the plan filed in D.L.R.S. M.P. 237/40.
