SUBSIDIARY LEGISLATION.

No. 284. THE DEFENCE REGULATIONS, 1940.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 61 of the Defence Regulations, 1940, I hereby order as follows :—

1. This Order may be cited as the Defence (Motor Spirit) (Rationing) Amendment Order, 1940, and shall be read as one with the Defence (Motor Spirit) (Rationing) Order, 1940, (hereinafter called "the principal Order") and the principal Order and this Order may together be cited as the Defence (Motor Spirit) (Rationing) Orders, 1940.

2. Clause 13 of the principal Order is hereby amended by the deletion therefrom of the words "as I may authorize by writing under my hand" and the substitution therefor of the words: "as I or the Commissioner of the District may authorize in writing in that behalf."

No. 285. THE DEFENCE REGULATIONS, 1940.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 61 of the Defence Regulations, 1940, I hereby order as follows :—

1. This Order may be cited as the Defence (Return of Stocks of Motor Spirit) Order, 1940.

2. Within five days of the date of the publication of this Order in the *Gazette*, every person who has in his possession or under his control more than three tins, or twelve gallons, of motor spirit shall complete

and deliver to the Commissioner of the District in which such motor spirit is situated a return, in the form set forth in the Schedule hereto, in respect of such motor spirit :

Provided that nothing in this Order shall be deemed to apply to registered importers of motor spirit.

3. Every person shall permit such person as I, or the Commissioner of the District, may authorize, by writing in that behalf, to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with, or for the purpose of checking the correctness or accuracy of any return made by any person under clause 2 of this Order.

4. Any person who—

(a) acts in contravention of, or fails to comply with, any of the provisions of this Order, or

(b) makes a return under clause 2 of this Order which is false in any material particular,

is liable to the penalties prescribed in Regulation 94 of the Defence Regulations, 1940.
