**No. 297. THE FOREST LAW, 1879.**

**ORDER IN COUNCIL No. 1962**

**MADE UNDER SECTION 30.**

*Governor.*

I, the Governor in Council, in exercise of the powers conferred by section 30 of the Forest Law, 1879, do hereby direct that, from and after the date hereof, the portion of the Trakhonas-Halasmata Forest described in the Schedule hereto shall cease to be under the control and management of the Government.

**SCHEDULE.**

That portion of the Trakhonas-Halasmata Forest in the District of Famagusta being an area of 7 donums and 2 evleks or thereabouts more particularly shown as plot 211 of sheet III, plan 63. of the Government Survey Series of Plans.

**No. 298. THE DEFENCE REGULATIONS, 1940.**

**ORDER BY THE GOVERNOR UNDER REGULATION 55.**

*Governor.*

I, the Governor, in exercise of the powers conferred by Regulation 55 of the Defence Regulations, 1940, do hereby order as follows:—

1. This Order may be cited as the Defence (Control of Traffic) Order, 1940, and shall come into operation on and from the date of its publication in the *Gazette*.

2. Upon the sounding of an air raid warning in any town, all vehicles and animals in any street within the municipal limits of such

town shall, at once, be drawn to the side of the street in such a manner as not to obstruct such street, and be brought to a standstill.

3. All such vehicles and animals shall remain at a standstill until the "All Clear" signal is given.

4. Animals harnessed to a vehicle shall be taken from such vehicle and be tethered at the side of the street.

5. Nothing in this Order shall apply to vehicles used by the Air Raid Precaution Organization bearing the letters "A.R.P." as a distinguishing mark or to vehicles used by any member of His Majesty's Forces or of the Cyprus Police Force in the course of their duty as such.

6. Any person who acts in contravention of this Order is liable to the penalties prescribed in Regulation 94 of the Defence Regulations, 1940.

**No. 299. THE EMERGENCY POWERS (DEFENCE) ACT, 1939.**

**REGULATIONS MADE BY THE GOVERNOR.**

I, the Governor, in exercise of the powers conferred by the Emergency Powers (Defence) Act, 1939, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, do hereby make the following regulations:—

1. These Regulations may be cited as the Defence (Amendment No. 1) Regulations, 1940, and shall be read as one with the Defence Regulations, 1940, (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these Regulations may together be cited as the Defence Regulations, 1940 to (No. 1) 1940.

2. Paragraph (1) of Regulation 66 of the principal Regulations is hereby revoked and the following paragraph substituted therefor:—

"(1) Subject as hereinafter provided, the Governor, if it appears to him to be necessary or expedient so to do in the interests of public safety, defence or the efficient prosecution of the war, or for maintaining supplies and services essential to the life of the community, may by order provide for the requisitioning of—

*New 44/207* ~~(a) any chattel in the Colony (including any vessel or aircraft and anything on board a vessel or aircraft); and~~

<sup>1.9</sup> (b) any ship or aircraft registered in the Colony or anything on board such ship or aircraft wherever the ship or aircraft may be;

and may give such directions as appear to him to be necessary or expedient in connection with the requisition:

Provided that the preceding provisions of this Regulation shall not authorize the requisitioning of any United Kingdom or Dominion ship or aircraft or of anything on board a United Kingdom or Dominion ship or aircraft."
